



1. The Executive Engineer, Paralakhemundi (R&B) Division on behalf of Governor of Odisha Invites Percentage rate bids in **Single cover** system in **ONLINE MODE** for the construction of works as detailed in the table below from class of eligible contractors as mentioned in Column-5 (five) registered with the State Government and Contractors of equivalent Grade / Class registered with Central Government / MES / Railways for execution of works. The proof of registration from the appropriate authority shall be enclosed along with the bid. If successful, the bidder who has not registered under State Government has to register under the appropriate registering authority of the State Government of Odisha in appropriate class of eligibility before award of the work.
2. The bidders may submit bids for the following works



Bidder shall transfer **“online”** the Earnest Money deposit/ Bid security and Cost of Bidding for the amount specified for the work in the table col No. -6 & 7 above as part of its bid though a process as mentioned under DTCN Bidders desirous to hire machineries or equipments from outside the state or owned but deployed outside the state are required to transfer online 2% of the amount put to tender as Bid security.
5. The Bid documents will be available in the website www.tendersorissa.gov.in from **10.00 Hours of 17.03.2018 to 17.00 Hours of 27.03.2018** for online bidding.
6. The bidder must possess Compatible Digital Signature Certificate (DSC) of Class II or Class III.
7. Bids shall be received only **“On-Line”** on or before **17.00 Hours of 27.03.2018**
8. Bids received **“On-Line”** shall be **opened (Technical Bid Cover-1) at 12.00 Noon on date: 29.03.2018** in the Office of the Executive Engineer, Paralakhemundi (R&B) Division in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.


9. The intending bidders are required to upload the scan copies of the Valid documents viz. valid original registration, GSTIN, PAN CARD, Affidavit, Machinery documents, Experience certificate & other required documents otherwise his/her bid shall be declared as non responsive and thus liable for rejection.
10. The intending bidders are required to produce documents viz: Original Registration Certificate, Valid GSTIN, Pan Card, Original Affidavit, for verification purpose, in the latter stage along with original documents of relevant documents as per eligibility criteria & DTCN for verification purpose only. Otherwise it will be treated non-responsive and thus liable for rejection.
11. Only those bidders who successfully remit their Cost of Tender Paper and Earnest Money Deposit on Submission of bids would be eligible to participate in the tender/bid process. The bidders with pending or failure payment status shall not be able to submit their bid. Tender inviting authority, State Procurement Cell, NIC, the designated Banks shall not be held responsible for such pendency or failure.
