The Executive Engineer, Ret Canal Division, Bhawanipatna on behalf of Hon'ble Governor of Odisha invites On-line P₁ -Percentage rate tenders through e-procurement for execution of the following work. The bid should be submitted by the eligible class of contractors as mentioned below, registered with State Governments & contractors of equivalent grade / class registered with Central Government / MES / Railways through On-line in the Govt. website www.tendersodisha.gov.in. The bidders should have necessary portal enrolment (with own digital signature certificate). The registered bidders outside of Odisha State can also participate in this on-line tender process after necessary portal enrolment but shall have to subsequently undergo registration with appropriate authority of the Odisha State govt. before signing of the agreement within a month of acceptance of bid. The bidders registered outside the State are required to submit an undertaking in the form of an affidavit, that they are not registered under the GST-2017 Act in the State of Odisha as they have not started any business in the State and they have no liabilities under the Act.

Bidders desirous to hire machineries or equipment from outside the State are required to furnish 2% of the amount put to tender as additional Bid security.
- 4. Only those bidders who successfully remit their cost of tender paper and Earnest Money Deposit on submission of bids would be eligible to participate in the tender/bid process. The bidders with pending or failure payment status shall not be able to submit their bid. Tender inviting authority, state procurement cell, NIC, the designated Bank shall not be held responsible for such pendency or Failure.

- 7. Bid validity period of the Tender is for a period of 90 days from the last date of receipt of bids. If any bidder renderer/ withdraws his Bid/ Tender before the said period or makes any modification in the terms and conditions of the Bid, the EMD deposited at the time of submission of tender / bid shall stand forfeited.
- 8. Bid must be accompanied with scanned copies of valid Registration Certificate, GST Registration Certificate, No relation Certificate and PAN Card failing which the bid will be rejected. Bidders desirous to avail exemption / relaxation of E.M.D. as per prevailing rules should upload copies of necessary documents and affidavit in support of their claim along with their bid. Bidders registered as "Engineer Contractor" desirous to avail exemption of E.M.D. for participating in bid shall have to upload an affidavit for not having availed this facility in three works during the year 2018-19. In such case, the successful Engineer Contractor has to produce the original Registration Certificate for recording the fact of availing exemption of E.M.D. for award of the work. Bidders registered as "S.C. & S.T. Contractors" desiring to avail concession(s)/ Price preference as per prevailing rules should apply for the same in writing in shape affidavit.
- 9. The bidders shall have to upload an affidavit in support of authenticity of documents/credential failing which the bid will be rejected. The authority reserves the right to verify the authenticity of documents in case of any doubt or complain.
- 10. The bidder can submit only one tender paper for a particular work, submission of more than one tender paper by a bidder for a particular tender will liable rejection of all such tender papers as per works department Letter. No. 4985/W Dtd. 28.03.2017. The bidder can download the tender of his choice and save it in his system to undertake necessary preparatory work off-line and upload the completed tender at his convenience before the final date and time of submission is allowed.
- 11. The technical Bids will be opened on-line on **29.08.2018** at **11.00** A.M., in the presence of the bidders who wish to attend if the office happens to the closed on the date of opening of the bids as specified, the bids will be opened subsequently on the next working day at the same time and venue.
- 12. No Engineer or Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering department of the State Government is allowed to work as a contractor for a period of two years after his retirement from Government service, without Government permission.

- 13. The scanned copy of Contractors Registration certificate, GSTIN Registration Certificate, PAN card and Affidavits, including all required papers should be uploaded in web-site and submitted at the time of online submission of Bid. The original documents of the same should also be submitted at the office of the Executive Engineer, Ret Canal Division, Bhawanipatna, Dist: Kalahandi / Chief Construction Engineer, Ret Irrigation Project, Bhawanipatna for verification on working days from **25.08.2018 to 28.08.2018** during office hours through a letter duly signed by the bidder.
