Sealed Quotations in plain paper/letter pad are invited from the intending Registered Firms/Suppliers/Authorised Dealers located at Bhubaneswar having valid GST Registration Number/Clearance Certificate /Income Tax Clearance Certificate and Pan Card for supply of Computer consumables for official use in Industries Department. The list of Consumables can be obtained from OE Section, Industries Department on any working day between 2.00 P.M. to 4.00 P.M. The Quotationer shall have to furnish their offer/price of the articles including taxes there on in the following format, along with terms and conditions if any. The prices quoted should remain valid for one year as need based orders will be placed from time to time. The Quotationers should deposit earnest money of Rs.1000/- (Rupees One Thousand) only in shape of A/C Payee Bank Draft/Pay Order payable to the DDO-cum-Under Secretary to Government, Industries Department which will be refunded to the Quotationers those quotations are not accepted. The EMD of the successful Bidder/Quotationer will be converted to Security Deposit to be reserved with this Department for a period of one year. In case of failure to supply the consumables in time or to maintain quality of the items the EMD will be forfeited.


