In pursuance of G.A. & P.G. Deptt. Resolution No. 23750/Gen dtd.27.8.2014, applications are invited from the retired Group-D Malis/Sahakari Malis of G.A & P.G. (Arbo) Deptt. who are eligible as per the conditions detailed below for consideration for engagement to work as Sahakari Mali in Group-D Post on contractual basis in the Arboriculture Organization of G.A. & P.G. Deptt. for one year or till the filling up of the vacancies, whichever is earlier. Their consolidated remuneration will be fixed @ Rs.6500/- per month excluding pension and T.I which he/she avails as per Finance Deptt. OM. No.7022/F., dated 17.03.2018. **2. Eligibility conditions:** (i) The retired Malis/Sahakari Malis who have retired from Govt. service on attaining the age of superannuation and below the age of 65 years having good service records and are physically fit shall be eligible to be considered for engagement.

(ii) The retired Malis/Sahakari Malis against whom departmental proceedings or criminal cases are contemplated/pending or who have been penalized for misconduct during the period of preceding 5 years will not be eligible for consideration for engagement.

**3. Other terms and conditions:** (i) The period of contractual engagement shall not be counted as Government service for the purpose of pension or any other retirement benefit

(ii) The engaged employees will be subject to and will abide by the Conduct Rules applicable to the Government servants

(i) The contractual engagement can be terminated at any time due to unsatisfactory performance by giving one month's notice. If the contractual employee desires to resign, he/she shall do so by giving one month's written notice to the competent Authority.
