Sealed quotations are invited from interested reputed Travel Agencies/Tour operators or private individuals having valid GST Registration certificate for providing one no of AC Diesel driven vehicle TUV 300 /Ertiga (Preferably Petrol) having sitting capacity not more than 07 (Seven) including driver. which shall confirm to the Terms and condition for official use in O/O AEE RWS&S Sub Division, Jharsuguda on monthly rent basis.

The following term and conditions shall be fulfilled by the bidders as per Annexure-II of the Finance Department Govt of Odisha Office Memorandum No. 34085 / F dt. 29.09.2012 and 30464 / F, dt. 06. 09. 2019.

- The hired vehicles, during period of contract, shall have all necessary valid MV documents such as: - valid registration certificate, insurance certificate, fitness certificate, valid contract carriage permit, proof of up-to-date tax payment etc The Department /officer hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles or loss of life / injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation. 2.
  - The vehicle shall not be more than 3 years old from the date of initial registration and also in good condition during the period of contract. 3.
  - The vehicle will remain inside the office premises or in the garage attached to the residence of the Executive Engineer RWS&S -Division, Jharsuguda after the duty 4.
    - Its shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
  - The hire charges to be paid for monthly basis is final but does not include cost of diesel. 5. which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential coolant, Types & tubes, Battery etc will be borne by the bidder.
