RE-QUOTATION CALL NOTICE

With reference to earlier quotation Call Notice No.10243 dt.14.07.2022 Re-sealed quotation /tender are invited from interested reputed Travel Agencies/Tour Operator or private individuals for providing one number of Non-AC / AC preferably Tiago/ Bolt/ Celereo or any higher version vehicle/ Bolero Diesel driven vehicles having sitting capacity not more than 5 including Driver, for official use in the Directorate of Fisheries, Odisha, Cuttack on monthly rent basis. Please also quote rate and mileage offered per Km. in bid sheet for Non AC and AC separately. The intending party must satisfy the Agreement laid down in Annexure-A which would be provided at the time of receipt paper.

- 1. The vehicle must be in Road worthy condition. Shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, Proof of up to date tax payment, pollution control certificate etc, which are mandatory for plying of vehicle. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport
 - The Driver of the vehicle must have a valid Driving License
 - The Driver should be well behaved, gentle and obedient in nature.
- 4. A Sum of Rs.5000/- (Rupees five thousand) only shall be deposited by the intending bidders in shape of Account payee Bank Draft drawn in favour of the D.D.O, Directorate of Fisheries, Odisha, Cuttack and submit along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
 - The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel & lubricants).
 - 6. The vehicle must achieve a fuel efficiency of 17 Kms per litre.
- 7. The details of the make and year of manufacture of the vehicle, registration number, mileage (Kms covered per liter) and name of the Driver with Driving License No. and period of validity should be specially provided in the general bid information to
- 8. The Quotation completed in all respect should reach the undersigned on or before 02.09.2022 by 2 P.M. & the same will be opened on 02.09.2022 at 3 p.m. The opening will be done by Addl. Director (Admn.) Directorate of Fisheries, Odisha, Cuttack. The interested bidders or their authorized agents may also attend the opening at the scheduled date /time. If in case the date of receipt/ opening will be declared holiday, the next day will be taken as receipt / opening tender.

The application form of quotation/tender containing General Bid Information & Terms and conditions for Hiring of Vehicles etc. will be available with the Mechanical Section of this Directorate on payment of Rs.100/-(Rupees one hundred) only in the office hour only till receipt of tender paper or can be download from Odisha Govt. Website www.Odisha.gov.in. In case the application form is downloaded from Govt. website, the applicant shall furnish a Demand Draft for an amount of Rs.100/ (Rupees One hundred) only towards the cost of application along with the application.
