Publication of Provisional Results of the Written Test and Provisional Screening List for Document Verification of MPHWF-2023

In pursuance of this Commission's Advertisement No. IIE-04/2023-585(C)/OSSCC dt.29.04.2023, Corrigendum No. IIE-04/2023-736(C)/OSSCC dt. 04.10.2023 and Notice No. IIE-37/2023-780(C)/OSSCC dt. 31.10.2023, the Provisional Results of the Written Test held on 03.12.2023 for the post of Multipurpose Health Worker (Female)-2023 is hereby published in the Commission's web portal. The Provisional Master Merit List have been prepared as per Para 11 of the advertisement on the basis of the marks secured by the candidates in the Written Test and the marks awarded to Short-Term COVID-19 Healthcare Workers, if any, as per rules. Candidates have been screened @125% of the vacancies advertised for the purpose of document verification. The following lists are published for information of candidates.

The allocation of districts will be done as per their merit and the choice to be exercised in order of preference by the candidates on or before document Verification. Candidates, after logging into their account, have to click on **Candidate Post Preference and Posting Preference** appearing under On-Line Application Management System in 'Applicant Menu' to exercise their choice in order of preference.

The verification of original documents and validation of Biodata of the candidates for MPHWF-2023 shall be conducted with effect from **15.02.2024** in the office of Chief District Medical & Public Health Officer of each district as per schedule.

All the aforesaid candidates are mandatorily required to attend the document verification process before the District Level Board as per the schedule & venue given in their Intimation Letters. If any candidate fails to attend document verification process, her candidature shall be rejected and she shall not be allowed to participate in the recruitment process any further.

It is also made clear that candidature of the candidates for this recruitment is purely provisional and is liable for rejection in the event of inadequacy/deficiency found at any stage. Mere participation in the document verification process does not confer any right upon the candidate for appointment.

The candidates are advised to download the Intimation Letters by logging in the web portal of the Commission www.osscc.gov.in with their User ID and Password for document verification.

The aforesaid information is hereby made available as PROACTIVE DISCLOSURE under the provisions of Right To Information Act, 2005. This will remain available for a period of 60 days for the candidates in the portal. Candidates are advised not to seek these information in any other mode like e-mail, grievance, Janasunani & RTI.

No hardcopy of Intimation Letter will be sent to any candidate by post.
