The allocation of Posts/Departments will be done on merit as per the choice of the candidates.

If any candidate fails to attend document verification process, his/her candidature shall be rejected and he/she shall not be allowed to participate in the recruitment process any further.

It is also made clear that candidature of the candidates is purely provisional and is liable for rejection in the event of inadequacy/deficiency found at any stage. Mere participation in the document verification process does not confer any right upon the candidate for appointment.
