2nd CORRIGENDUM TO e-TENDER NOTICE NO. 1644 dated 02.03.2024

In pursuance with Technical Committee meeting for consideration of the submissions of prospective bidders in the Pre-bid meeting held on 15.03.2024, following is hereby incorporated in the e-tender bid documents issued vide e-Tender Notice No. 1644 dated 02.03.2024:

1. Annexure-1: List of Equipment with Technical Specifications of the Tender Document is hereby revised by incorporating the recommendations of the technical committee. The Final List of Equipment along with Proceedings is enclosed at Annexure-1.
2. An undertaking/ affidavit should be submitted by the bidders to ensure that they have not been declared ineligible, non-performing, involved in fraud or blacklisted etc. by any State Govt. / Central Govt. / PSU and if found involved in any of the above fraudulent practices any time, their bid may be cancelled or rejected summarily.
3. There should be service centres setup at Odisha by the selected agencies for repair, replacement and maintenance of the equipment to be installed for seamless post sales service. The agreement of the selected bidder should be legally vetted by experts so that any dispute regarding maintenance of the equipment can be addressed in time properly.
4. Department will consider installation of the equipment by the selected (L1) bidder in one or two centres initially so that after three months of operation the performance can be judged and reported on the basis of data. On the basis of satisfactory performances, installation in other centres may be considered during the year.
5. Last date for submission of e-tender bids was extended up to **27.05.2024-5PM** vide corrigendum notice no. 2593/SSEPD dtd. 22.03.2024. Technical Bids will be opened on Dt. 28.05.2024- 11.30 AM at Conference Hall of SSEPD Department, Loksewa Bhawan, Bhubaneswar.
