Selection of Incubatee in Apparel Manufacturing by Orissa State Co-operative Spinning Mills Federation Ltd. (SPINFED) for “SPINFED INCUBATION CENTER” at Patia, Bhubaneswar, Odisha.

Terms of Reference (ToR)

1. Introduction :

The SPINFED, Odisha is an Apex organization of Cooperative Spinning Mills and Power loom Societies of the State of Odisha. It functions under the administrative control of Handlooms, Textiles & Handicrafts Deptt., Govt. of Odisha. The main objectives of this Apex Federation are:-

- a. To Promote Textile Industries in the State right from the Cotton Ginning, Pressing, Spinning, Weaving, Processing & Apparel Industries etc.
- b. Formulate Apparel & Textile policies to encourage investors / entrepreneur for setting up of textiles & its allied industries in the State.
- c. To create skill work force in textile and apparel sector.
- d. To create employment opportunities in textile sector.
- e. To create awareness among the ginners, spinners, power loom weavers and apparel manufacturing operators for the improvement of quantitative and qualitative production in conformity with national & international standard through training programs and seminars.

2. Objective:

The main objective to create an integrated workspace and linkages based entrepreneurial ecosystem for start-ups that is operationally and financially viable and increase the chance of success of start-ups and decreases the time and cost required to establish and grow a new business:

- a) Promote entrepreneurship in apparel manufacturing.
- b) Create additional manufacturing capacity.
- c) Generate additional employment opportunities.

3. About the project :

- a) SPINFED shall establish an Incubation Centre in an area of One Acre land under the Scheme for Incubation Centre in Apparel Manufacturing of Ministry of Textile, Govt. Of India at Patia, Bhubaneswar.
- b) The Incubation centre shall have a maximum of 3 (Three) incubates.
- c) The incubatee shall manufacture products related to apparel industry, which do not have high water requirement.
- d) Each Incubatee shall use 100 stitching machines along with ancillary machinery.
- e) SPINFED shall provide ready-to-use plug & play factory building with a total built up area not exceeding 45,000sq ft (@15000 sq ft per incubatee) which will be spread over a maximum of three levels (G+2) and may comprise of operation area , packing ,office , store , workers' amenities and display etc.
- f) The site / area shall be provided on “As is where is basis”
- g) There shall be training support for 200 workers per incubatee, training on Entrepreneurship Development to each incubatee, training on Product Design and Development Service and support to market linkages through exposure visit/ participation in domestic exhibitions and visit to international fair.

4. Incubation Period :

- a) The period for each Incubatee shall be 03 (Three) Years during which it is envisaged that the entrepreneur will be fully trained and capable to run an apparel venture independently.
- b) After completion of the Incubation period of three years, he / she has to vacate the Centre.

5. Roles and Responsibilities of Incubatee :

- a) To carry out the approved activity from the Incubation Centre.
- b) To operate, maintain and manage the project facilities during his /her tenure.
- c) To ensure working capital for the project.
- d) To participate in the capacity building programmes.
- e) To execute an agreement with SPINFED for operationalisation of the centre as envisaged under the Scheme.
- f) To pay users charges for utilizing infrastructure and machineries of Incubation Centre in time as to be fixed by SPINFED.
- g) To pay electricity charges of their own consumption for the allotted work space.
- h) To pay other recurring charges in time towards common facilities such as maintenance, electrical and security charges as to be fixed by SPINFED.
- i) To work closely with SPINFED in establishing market linkage.
- j) To make full investment in running the unit successfully and uninterruptedly.

6. Roles and Responsibilities of SPINFED/ State Government.

- a) Govt. shall provide all requisite clearances, wherever needed, for setting up the incubation centre.
- b) Govt. shall provide necessary assistance for power, water & other utilities to the centre including other facilitating support.
- c) To provide the infrastructure and machineries for Apparel manufacturing in plug and play manner.
- d) To provide the security and other logistic support for safeguarding and maintenance of common space of the Center.
- e) To execute an agreement with incubatee for operationalization of the centre as envisaged under the Scheme.
- f) To operate the incubation centre through collection of rentals and other user charges for sustainability.

7. Eligibility Criteria :

- a) Incubatee shall be identified and selected from the any of the following category of individuals :
 - I. Degree/Diploma holders of any discipline related to textile, apparel, fashion designs etc.
 - II. First generation entrepreneurs.
 - III. Designpreneurs.
- b) Should have a sustainable business plan and submit a project report for the same (As per Annexure -1).

8. Selection and Evaluation Criteria:

The selection will be done through a transparent procedure by the Incubatee Selection Committee. The Incubatee will be selected after evaluation of their credential, project report along with the financial proposal submitted by each of them followed by presentation. The merit list of candidates will be decided on the basis of mark secured. Candidates found successful as per merit list would be communicated the award of incubatee assignment.

9. Other Terms and Conditions:

- a) The incubatee shall not let out or lease out the space in part or full of the incubation centre under any circumstances.
- b) The incubatee should not have been indicted or convicted by any court of law and he must furnish an undertaking to this effect.
- c) SPINFED reserves the right to add/amend/withdraw/modify any of the above terms and conditions at any stage without any notice. The decision of SPINFED in this regard will be final.
- d) Violation of any terms & conditions or any rules / regulation framed by State Govt. as well as SPINFED or non-payment of dues in time etc., shall result in initiating action by SPINFED , as deemed fit , including eviction of the incubatee from the Incubation Centre.

10. Processing fees & Security deposit :

- a. Interested candidates will furnish processing fees (Non-refundable) of Rs. 5000/- (Rupees Five thousands) only in the form of Demand Draft / Banker's Cheque from a scheduled commercial bank, drawn in favour of **"Orissa State Co-operative Spinning Mills Federation Ltd"** payable at **Bhubaneswar**.
- b. Successful incubatee will have to furnish Security deposit of Rs. 1,00,000/- (Rupees One Lakh) only in the form of Demand Draft / Banker's Cheque from a scheduled commercial bank, drawn in favour of **"Orissa State Co-operative Spinning Mills Federation Ltd"** payable at **Bhubaneswar**. The same will be refunded after completion of incubation period without any interest.
- c. The Security deposit will be forfeited, in case, the incubatee will leave the centre prior to completion of the incubation period.
