The rates should be inclusive of all taxes like excise duty, CST, entry tax, service tax, conveyance, and freight and packing etc. complete including Fitting fixing as instructed for each item with FOR at site i.e at Secretariat Building, Bhubaneswar, Odisha in different departments as directed by consignee.
  9. The validity period of the quotation should be 45 (Forty five) days from the date of submission of quotations.
  10. The quotations not accompanied with EMD as specified above, copies of VAT, PAN, and TIN/SRIN Clearance Certificates will be summararily rejected. The valid quotation with lowest offer shall be taken in to consideration.
  11. The intending participants into the competition in response to the quotation call notice should note that.
    - The supply, fitting, fixing and testing etc of this assignment should be completed in all respect within 60 (Sixty) days from the issue of the work order.
    - The materials should be delivered at the site in good condition under intimation to the consignee for inspection and testing etc. prior to fixing, fitting or installation etc.
    - Insurance coverage to the materials for transit and coverage of insurance to labourer components etc. till the completion of the work is at the risk, responsibility and cost of the agency assigned with the work. The materials or installation if found unsuitable or beyond specification should be replaced by the agency at his /their cost within 7(Seven) days from the date of intimation to that effect by the Engineer in charge.
    - The firm assigned with the work shall give warranty for two years from the date of supply of the materials.
    - The EMD of the unsuccessful participants shall be refunded within seven days of the finalisation of the selection process and the EMD of the selected agency/firm will be retained and will be refunded immediately on receipt of the completion report from the Engineer in charge.
    - An amount @5% of the bill in gross will be deducted and retained as performance security till one year from the date of satisfactory completion.
    - The Executive Engineer, Bhubaneswar R&B Division No.1 or his authorised Assistant Engineer-in-charge of the work is the consignee for all purpose and the payment will be made by the Executive Engineer, Bhubaneswar R&B Division No.1. The bills in triplicates along with the copies of the documents in support of payment of all taxes ,statutory dues of State Government or Central Government etc., completion certificates, test certificates on materials, BIS certificates if any, in three sets should be submitted to the paying authority for release of the payment within seven days.
    - Non-completion of the work within the stipulated period will carry penalty @ 0.5% of the value of the work order per day subject to maximum 5% of the value of the work order towards delay. Exceeding that the work order stands cancelled automatically and the EMD will be forfeited and taken into Government account .If there is genuine reasons for delay , the same should be brought to notice of the Executive engineer immediately for allowing the reasonable time after due verification to the facts.
