1. On behalf of Odisha Construction Corporation Ltd. ("OCCL"), the Senior Manager (Civil), Lower Suktel Spillway Project, Balangir invites sealed quotations on item rate basis from OCC Ltd. enlisted job workers for execution of the following work: -

In such case, the quotationers have to deposit the cost of Quotation paper as above by non-refundable Demand Draft to be drawn on or before dt. 10.08.2017 from any nationalized / scheduled bank payable at Balangir in favour of Odisha Construction Corporation Ltd. during submission of the Quotation.
 - The Quotation must be accompanied with EMD (Earnest Money Deposit) amounting Rs. 9,72,000.00 (Rupees nine lakhs seventy two thousand) only in shape of A/C Payee Demand Draft in favour of "Odisha Construction Corporation Ltd." from any nationalized/scheduled bank payable at Balangir.
 - 3. The Quotation is to be dropped in the tender box in a cover containing Cover-I & Cover-II.

COVER-I:

Cover-I (Technical Bid) must contain the following documents and is to be sealed and super scribed as 'Cover-I' (Technical Bid) and name of the Work.

- a) Quotation paper Cost
- b) Earnest Money Deposit (EMD)
- c) Valid Enlistment Certificate (issued by OCCL)
- d) G.S.T No.
- e) PAN No. with photocopy of PAN card
- f) Affidavit regarding authenticity genuineness of certificates.
- g) Undertaking regarding No relationship certificate
- h) Copy of EPF registration, if any
- i) Technical Bid documents duly filled in (wherever required) and

COVER-II :

Cover–II must contain the price bid duly filled in and signed by the bidder along with the Addl. Performance Security if any, and is to be super scribed as "**Cover – II** (**Price Bid**) and **Name of work**.

Both the covers are then to be kept inside a **Third Cover** duly sealed and super scribed with the name of the work, Quotation call Notice No. In order to ensure that the envelopes are properly sealed, the job worker can seal them with superglue and also add tamperproof tapes as additional precaution.

- 4. The quotationers are not required to write their name on the outer cover containing the quotation documents (Cover-I & Cover-II). They are only required to write the name of the work, Quotation Call Notice No. and the Authority inviting the bid.
- 5. The Quotation must be dropped in the Tender Box specified for the work and kept either in the Tender Box Room of the Corporate Office (2nd Floor), Unit-VIII, Gopabandhu Nagar, Odisha or in the Office of the Chief Construction Engineer, Lower Suktel Irrigation Project, Laltikra, Balangir on or before 01.00 PM on dt. 10.08.2017 The Cover- I (Technical Bid) will be opened on dt. 11.08.2017 at 3.30 P.M. at the Corporate office of OCC Ltd at Bhubaneswar in presence of the bidders or their authorized representatives, who may likely to be present. If there will be a public holiday on the last date of receipt & opening of the Quotations as specified above, the Quotation documents shall be received & opened on the next working day at the same time & venue.

Date, time and place of opening of **Cover- II** (**Price Bid**) shall be intimated separately to those bidders who will be found eligible after evaluation of Technical Bids. Cover-II containing the Price Bid shall be returned unopened to the unsuccessful bidders after completion of the Tender process.

- **6.** Qualification Criteria: Please refer Para 4 of ITQ (Instruction to Quotationers) of the Bid Document (Technical Bid).
- 7. Additional Performance security shall be put inside Cover-II along with the Price Bid, when the amount of the bid/Quotation is less than the value of the work put to Quotation.

In such case, the quotationer has to deposit the additional performance security equal to the differential cost (Quotation value minus quoted value rounded to the nearest thousand) in shape of A/c Payee Demand Draft only from any nationalized/scheduled bank pledged in favour of Odisha Construction Corporation Ltd. payable at Balangir, **failing which the Quotation will not be considered.**

- 8. The job workers shall have to furnish an **affidavit** in support of the authenticity/ genuineness of the documents/certificates and credentials submitted along with the Quotation document. In case of production of forged document, the penalty shall be rejection of their Quotations and cancellation of their enlistment with the Corporation. The authority reserves the right to verify the authenticity of documents in case of any doubt or complain.
- 9. The Quotation received will remain valid for 90 (Ninety) days from the last date of receipt of Quotations and the validity of Quotations can also be extended if agreed to by the bidder(s) and OCCL
- 10. The Contractor shall have to execute the work as per conditions of agreement & technical specification.
- 11. The authority reserves the right to accept or reject the Quotation and to split up the work to award to one or more job workers without assigning any reason thereof.
- 12. Any dispute arising out of the above Quotation call notice shall be subject to Jurisdiction of Hon'ble High Court, Odisha, Cuttack and their sub-ordinate courts at Bhubaneswar.
