Under no circumstances, they would be allowed to indicate any other type of taxes and no other terms and conditions will be accepted after finalization of the quotations. The quotationers are required to provide all equipment, spare and service charges and consumables.
- 3. The quotationers are required to provide Xerox machine in good condition, all equipment, spare and service charges and consumables including toner. It will be incumbent upon the quotationer / bidder to ensure that the Xerox machine works in good condition.
