**TERMS AND CONDITIONS FOR HIRING OF VEHICLES**

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

- 01 The hired vehicles, during period of contract , shall have all necessary valid MV document such as :- Valid Registration Certificate, Insurance certificate, Fitness certificate, Valid contract Carriage Permit , Proof of up to date tax payment etc. and D.L. of the driver available all the times , the Department/Office hiring the vehicles shall not be responsible for any damage / loss caused to hired vehicles or loss of life/injury made to any person or damage to any property on account of us of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
- 02 The hire charge to be paid for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts. Lubricating oil of Engine, Gear Box & differential Coolant, Tyres& Tubes, Battery etc will be borne by the bidder.
- 03 It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
- 04 In case of breakdown for reason whatever the replacements of a vehicle of the same or better model shall be provide by the owner of the vehicle/bidder.
- 05 In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other sources.
- 06 The vehicles shall report for duty throughout the month.
- 07 In case of emergency, the driver will have to report for duty as per the requirement of hire. No extra payment shall be demanded.
- 08 Monthly hire charges and reimbursements towards cost of diesel (as per actual) and lubricants (as per Government norms) & parking charges as per actual of selected bidder will be paid in every succeeding months, as far as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
- 09 The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract.
- 10 If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
- 11 In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
- 12 If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.
