
TENDER CALL NOTICE

No. OE-D-19/2016-10987 /FSCW, Dated:-29.05.2017

Sealed tenders are invited from interested reputed Travel Agencies/Tour Operators or private individuals for providing 01 (one) number of Diesel driven Indigo (AC) car having sitting capacity not more than five including driver, which shall confirm to the Terms and conditions (given in Annexure-II) for official use in FS & CW Department on monthly rent basis:

- 1) The vehicle must be in Road Worthy condition, shall not be more than 3 (three) years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- 2) The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 3) The Driver should be well behaved, gentle and obedient in nature.
- 4) A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the D.D.O., FS & CW Deptt. and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 5) The monthly rate of hire charge has been quoted separately in the general bid information (excluding fuel and lubricants).
- 6) The vehicle must achieve a fuel efficiency of 15 (fifteen) Kms per liter and hire charge will be Rs.18,000/- per month or less than it.
- 7) The details of the make and year of manufacture of the vehicle, registration No., mileage (Kms covered per liter) and name of the driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Tender .

- 8) The Quotation completed in all respect should reach the undersigned on or before 12.06.2017 by 11.00 A.M. and shall be opened on the same day at 3.30 p.m. in presence of the bidders or their authorized representatives.
- 9) The application form of tender containing General Bid Information & Terms and conditions for Hiring of Vehicles etc. will be available with Office Establishment Section of the FS & CW Department on all working days on payment of Rs.100/- from 10 AM to 5 PM or can be downloaded from Odisha Govt. Website "www.Odisha.gov.in". In case the application form is downloaded from Govt. website, the applicant shall furnish a Demand Draft for an amount Rs.100/- (Rupees one hundred) only towards the cost of application alongwith the application.
- 10) The authority reserve the right to cancel any portion or total tender without assigning any reason thereof.
