The vehicle can be inspected in the office Garage of I & P.R.Department on any working day during office hour along with the documents of the vehicle. The tender should be accompanied with a bank Draft of Rs.1000/- (Rupees one thousand) only as earnest money in favour of Drawing and Disbursing officer, I & P.R.Department, Bhubaneswar for vehicle. The tender whose offer will be the highest and accepted by the competent authority shall deposit 25% of the offered amount immediately. The balance amount will be deposited with D.D.O.I & P.R.Department within seven days of confirmation of the bid, failing which the deposited amount including the EMD shall be forfeited. The tenderer should remove the vehicle from the site immediately on full payment of bid amount. In case the vehicle is not removed, custody and safety of vehicle shall be responsibility of the tenderer and no claim or complaint on that account shall be entertained. On failing to remove the vehicle within stipulated time, Ground rate at the rate of 1% of the bid money shall be charged for each day or part of the day for the vehicle till the removal of the vehicle from the site. If the ground rent so charged exceeds the sale price deposited, then the tenderer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent and the vehicle shall become absolute property of the Government.
