**NOTICE INVITING “ EXPRESSION OF INTEREST “ FOR ACADEMIC SESSION
2012-13**

Expression of Interest are invited from intending Printing & Binding S.S.I. Units of the State for execution of Printing/ Binding and delivery of Nationalised Text Books for the Academic Session **2012-13** at the prevailing Govt. approved rates and Terms and Conditions. Intending firms are required to submit the following documents alongwith their Expression of Interest in a sealed Cover superscribed “ **Expression of Interest for Printing/ Binding for the Academic Session 2012-13**” and the same shall reach the undersigned, latest by 5 P.M. of **11.07.2011** failing which they will not be eligible to be empanelled in the list of Printers/Binders for the execution of work for the Academic Session 2012-13.

Only such Web Offset Printers having minimum **Cut-Off size of 560 mm** need to apply who shall be considered for award of work. Intending firms may obtain the copy of prevailing Terms and Conditions available in this office or they may download the same from S&ME Website of Govt. of Orissa. Separate applications each for “ Printing” and that of “Binding” are to be submitted.

A. LIST OF DOCUMENTS TO BE ENCLOSED :

All the documents furnished shall be self attested by the authorised signatory of intending Firms, in full and under his/her Place, Date & Seal of the firm.

- a) Copy of up to date (having due validity) VAT clearance certificate for the year 2011-12.
- b) Copy of Registration Certificate under OVAT Act to be enclosed.
- c) Copy of the DIC registration certificate (Permanent/Entrepreneur Memorandum-Part-II).
- d) Copy of the Income Tax PAN Card.
- e) List of machines available.
- f) E.M.D. for Rs.15,000/- (Rupees Fifteen thousand)only for printing and Rs.10,000/- (Rupees Ten thousand) only for Binding in shape of NSC/ KVP/FDR/ duly pledged in favour of Director, Text Book Production & Marketing, Bhubaneswar. Tender without required amount of EMD shall not be taken into consideration. EMD deposited on earlier occasions, but not yet released from TBPM shall not be

adjusted against this "Expression of Interest". In case, any applicant is exempted from deposit of EMD, this fact shall be clearly mentioned and copy of the Govt. notification/order granting such exemption if any, shall be enclosed alongwith the application.

- g) Full address and correct Telephone/Mobile Number of the Proprietor as well as Authorised contact person.

1. The Expression of Interest will be received up to **5 P.M. on 11.07.11** either by Regd. Post/Speed Post/Courier Service or in Person. In case of any Postal/Courier delay, the Authority shall not be held responsible in any manner. Such Expression of Interest shall be made public at **11 A.M. on Dt. 12.07.11** in presence of the applicants or their authorised representatives of participating firms.
2. Works will be allotted to eligible firms on the recommendation of the Technical Committee and after their inspection of the individual firms and after verification about the authenticity of the documents furnished by the intending firms with respect to the original documents as stated above.
3. (a) All the interested "**Printers**" shall be in readiness with all their original documents including VAT Clearance Certificates as well as DIC Regd. Certificates for necessary verification and return at the office of the undersigned on **Dt. 13.07.11 at 10.30 A.M.**
 (b) All the interested "**Binders of Cuttack**" shall be ready with all their original documents including VAT Clearance Certificates as well as DIC Regd. Certificates for necessary verification and return at the office of the undersigned on **Dt.14 & 15.07.11 at 10.30 A.M.**

(c) All the interested "Binders of Bhubaneswar" and other locations of Orissa shall be ready with all their original documents including VAT Clearance Certificates as well as DIC Regd. Certificates for necessary verification and return at the office of the undersigned on **Dt.18.07.11 at 10.30 A.M.**

4. The Eligible firms shall be required to enter into an agreement with the authority and deposit the Security Amount as per the prevailing Terms and Conditions of works of the Academic Session 2009-10 .
5. For any false/incorrect information/documents submitted alongwith the "Expression of Interest" the authority reserves the right to undertake strict penal actions , including cancellation of work Orders, forfeiture of EMD/ Security Deposit / Bills of Payment, Blacklisting in addition to any legal actions that may be imposed.
6. Eligible participants shall be issued with Work Orders alongwith other instructions immediately after completion of all formalities. Only such firms shall be issued with 2nd/ subsequent phases of Orders on proper servicing of their Work Order as regards timely/qualitative delivery of Finished Books.
7. Bills of Payment shall be submitted in triplicate, duly authenticated and supported by valid Challans. Such bills shall then be considered for payment, on availability of Budgetary Funds and upon receipt of Govt. property i.e. Finished N.T.Books at TBPM Godowns from respective Printers & Binders.
8. The authority reserves the right to reject/cancel the offers of any firm or all applying firms, without assigning any reason thereof.
