Tenders on plain paper in sealed covers are invited by the undersigned for disposal of one TATA-INDICA-V2-(DLE) bearing No.OR-02 AB-5657.

The intending tenderers are advised to inspect the vehicle at the Secretariat premises on any working day during office hours between 11:30 A.M. to 03:00 P.M. before submitting tender. Each tender should accompany earnest money deposit of Rs.1,000/- (Rupees One thousand) only in shape of Bank Draft in favour of D.D.O., FS & CW Department payable at UCO Bank, Odisha Secretariat Branch, Bhubaneswar which will be refunded to the tenderer whose tenders are not accepted except in the case of successful bidder.

2. The tender/bid should reach the undersigned by dt.-10.09.2019..... up to 02:30 P.M. at the latest and tenders received shall be opened by the undersigned in FS & CW Department at 03:30 P.M. on ..... 10.09.2019 in the presence of the tenderer or their authorised agents. If this day is declared latter as a Government holiday then the tenders will be received and opened on the next working day as per the scheduled time.
3. The highest tenderer whose tender is accepted shall deposit immediately 25% of the offered amount as initial deposit. He shall deposit the balance amount within 7 (seven) days of the deposit of the initial amount. In case he fails to make deposit of the total amount as per the tender within the stipulated time, the deposit including the earnest money shall be forfeited. GST as admissible shall be levied on the bidding cost.
4. The successful bidder shall take permission and remove the vehicle from the Secretariat premises within two days of deposit of the total bid amount. On failure to remove the vehicle within the aforesaid time, ground rent @ 1% of the tendered amount shall be charged for each day or part of the day till removal of the vehicle from the Secretariat premises. If the ground rent so charged exceeds the sale price deposited, then the tenderer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent.
5. The authority reserves the right to reject any or all tenders without assigning any reason thereof.




