SEALED TENDER NOTICE


Tenders in plain paper in sealed cover are invited by the undersigned for disposal of one Ambassador A.C Car (Diesel) bearing Registration No. OR-02-AM-5555 (2006 make and purchased on 31.10.06) on "as is where in basis". The intending tenderers are advised to inspect the vehicles in the Secretariat premises on any working day during office hours between 3 pm to 5 pm, 7 days before the last date for submission of tender papers by contacting the Under Secretary to Govt.(OE) ;, School & Mass Education Deptt.

The tenderers' has to submit separate tender accompanying an Earnest Money Deposit (EMD) of Rs.1000/- (Rs. one thousand) only in shape of Bank Draft payable at UCO Bank, Secretariat Campus, Bhubaneswar in favour of the Under Secretary to Govt.(DDO), School and Mass Education Department. The EMD deposited in shape of Bank Draft will be refunded to the tenderers whose tenders are not accepted immediately after acceptance of highest offer by the competent authority. The tenders should reach the undersigned on or before 07.01.2019 at 1.00 PM at the latest and the tenders received shall be opened in the same day at 4.00 PM in presence of the tenderers or their authorized agents, if they so desire.

If this date is declared as a Govt. holiday, the tenders will be received and opened in the nex two working day as per the scheduled time. The highest tenderer whose tender will be accepted shall deposit 25% of the tendered amount immediately after the sale is confirmed and rest within 7 days from the date of acceptance of the tender.

The successful tenderers shall remove the vehicle from the site within 7 days (seven) from the date of depositing the full amount of the tendered amount. In case he fails to make deposit the amount in full as per the terms within the stipulated time, deposit including the earnest money shall be forfeited. This 25% of the tendered amount plus earnest money are subject to adjustment at the time of final payment of tendered value, if paid in time. On failure to remove the vehicle within the aforesaid time, ground rent at the rate of 1% of the tendered amount shall be charged for each day or a part there of till removal of the vehicle from the site. If the ground rent so charged exceeds the sale price deposited, the tenderers shall cease to have any right to the vehicle and the amount deposited by him shall be adjusted towards the ground rent.

The authority reserves the right to reject any or all the tenders without assigning any reason there of.
