12. Works will be taken up as per the availability of Funds.

In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of different cost i.e estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of Term Deposit Receipt pledged in favour of Divisional Officer/Bank Guarantee in favour of the Divisional Officer from any Nationalized /Schedules Bank in india counter guaranteed by its local branch at Bhubaneswar within seven days of issue of letter of Acceptance (LoA) by the Divisional Officer (by e-mail)to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/Bid Security shall be forfeited.
