- 1. Cost of Tender Paper-** The bidder shall transfer online the cost of bid document in the table Column 6 respectively as part of this bid through a process as mention under DTCN.
- 2. E.M.D. required –** The bidder shall transfer online the Earnest money deposit/ Bid Security of the amount specified for the work in the table Column 4 respectively as part of this bid through a process as mention under DTCN Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the State are required to transfer online 2% of the amount put to tender as bid security.
- 3. Additional Performance Security -** If the amount quoted by the bidder is more than 15% less than the tendered amount, then such bid shall be rejected and tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalise the tender through a transparent lottery system in presence of all the bidders/their authorized representatives which will be held in the office of Executive Engineer, Barpali Canal Division, Barpali in presence of all bidders/their authorized representatives, the Executive Engineer and Sr.DAO. Hence, all the bidders can enquire in the office of the undersigned regarding lottery before scheduled date as no further correspondence as no further correspondence to the bidders in this regard will be made. In the event of the specified date for drawal of lottery being declared a holiday for the officer inviting Bid, lottery will be drawn at the appointed time on the next working day.

Additional performance security shall be furnished by the successful bidder. When the bid amount is less than the estimated cost put to tender, in such an event, the bidders who have quoted less bid price / rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as **Additional Performance Security** in shape of **Term Deposit Receipt** pledged in favour of Divisional Officer (**Executive Engineer, Barpali Canal Division, Barpali payable at Barpali**) from any Nationalized/Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar within seven (7) days of intimation by the Divisional officer (by e-mail) to the successful bidder otherwise the successful bidder shall be cancelled and the Earnest Money Deposit/Bid Security shall be forfeited. Further proceeding of blacklisting shall be initiated against the bidder as **per Works Department Memorandum No.14299 dt.03.10.2017** and Amendment made vide **Office Memorandum No.14459 dt.20.09.2018**. The time period of such APS deposit must be more than the duration of work.

4. Only those bidders who successfully on-line remit their Cost of Tender Paper and Earnest Money Deposit on submission of bids would be eligible to participate in the tender/ bid process. The bidders with pending or failure payment status shall not be able to submit their bid. Tender inviting authority, State procurement cell, NIC, the designated banks shall not be held responsible for such pendency or failure.
5. **Goods and Service Tax (GST) will be paid extra as applicable.**

The system shall generate a mail to those bidders who have already uploaded their tenders and those bidders if they wish, can modify their tenders.
9. The Technical bid (**Cover-I**) document consisting of qualification, information and eligibility criteria of bidders, plans, specification and schedule of quantities of the works are available in web-site www.tendersodisha.gov.in and the set of terms and conditions of contract and other necessary documents can be seen in the web-site till last date of sale and receipt of tender papers. 10. The Financial Bid (**cover-II**) consisting of qualification, plans, specification and bill of quantities of the works are available in the web-site www.tendersodisha.gov.in and the set of terms and conditions of contract and other necessary documents can be seen & uploaded in the website till **07.11.2020 up to 17.00 hours** i.e. last date of availability of "on-line" bid for bidding. The date and time of opening of financial bid (**cover-II**) will be intimated to the qualified bidders after evaluation of technical bid (**cover-I**).
11. Bid document consisting of qualification, information and eligibility criteria of bidders, plans, specification and schedule of quantities of the works are available in web-site www.tendersodisha.gov.in and the set of terms and conditions of contract and other necessary documents can be seen in the web-site till last date of sale and receipt of tender papers. Interested tenderers may obtain further information at the web-site www.tendersodisha.gov.in.
12. The bid validity period of the tender is for a period of 120 days from the last date of receipt of bids. If any bidder/ tenderer withdraws his bid/ tender before the said period or makes any modification in the terms and condition of the bid, the EMD deposit at the time of submission of tender shall stand forfeited.

13. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a contractor for a period of two years after his retirement from Government service, without Government permission.
14. Other details including details of Portal Registration, Submission of bid, Resubmission and withdrawal of bid can be seen in the bidding document which is available in web-site www.tendersodisha.gov.in
15. The scanned copy of Affidavit submitted through web-site should be produced in original and other documents shall be physically produced before signing of agreement.
16. The bidders are required to submit the Xerox copies of the valid Registration Certificate, PAN Card and GSTIN Regd. Certificate along with the bid documents otherwise his/her Bid shall be declared as non-responsive and thus liable for rejection. The original documents are to be produced before the undersigned as and when required. Engineering Contractors who are desirous to avail the facility of Exemption of EMD is required to submit the affidavit in original to the effect that he has not yet availed the facility for more than two works during the current financial year. Name of the two works and authority to which the tender is being submitted must be mentioned in affidavit, failing which, the tender will be liable for rejection. However, the original registration license of the Engineering Contractor should be produced at the time of opening of tender. SC/ST contractors desirous to availing benefit as per Works Department Resolution No. 27748 dtd. 11.10.1977 and submit affidavit for the same along with attested copy of Caste Certificate.
17. **Engineer Contractors must state the nos. of works availed through award in the Affidavit to be uploaded with supporting documents during the calendar year and similarly SC/ST contractor must state the price preference in the Affidavit to be uploaded failing which no further claim shall be entertained later on.**
18. The Single tender received in the first call shall be cancelled without opening the bid. The acceptance of the single tender received even after retendering should have prior approval of next higher authority.
19. If the 1st lowest bidder does not turn up for agreement after finalization of tender, then he shall be debarred from participation in bidding for three years & action will be taken to black list the contractor.
20. The bidders shall furnish an affidavit on-line at the time of submission of the bid, about the authentication of the tender documents including Registration Certificate, PAN Card, valid GST clearance certificate and security etc. to the **Executive Engineer Barpali Canal Division, Barpali** failing which the bid shall be considered as non-responsive and thus liable for rejection. No adjustment of EMD will be entertained at all; Labour license is to be produced by the successful bidder at the time of agreement.
21. Amendment to para 3.5.18 of OPWD code Vol-I & rule 29 of Appendix-IX of OPWD code Vol-II "The single tender received in 1st call shall be cancelled without opening of the bid & fresh tender will be invited" as per Office Memorandum No 16 dated 01.01.2015 of Works Department, Govt. of Odisha.
22. Exemption of E.M.D. to engineering contractors is to be governed as per works dept. letter No. 6315 dtd:-16.6.2011.
23. The bidder should mention his detail address and phone no. in the separate sheet for communication regarding the tender. The date and time of the lottery will be intimated to the qualified bidders through their e-mail ID and contact number provided in the tender website.
24. The work performance of bidder under this division with respect to completion of previous projects within stipulated time will be taken into consideration while evaluating the bid.
25. If any bidder/ bidders desirous to appoint power of attorney holder for signing of agreement he/they must upload the authenticate documents regarding power of attorney, with the bid otherwise the bid will be considered invalid.
26. All bidders those who will participate in this bidding process must furnish their Email-id and contact no.

27. The bidder to submit a list of works on hand at the time of submission of Tender Papers. This will be taken into account while evaluation of tenders.
28. Authority reserves the right to reject any or all the tenders without assigning any reasons thereof.
29. All the existing provisions of OPWD code with amendment from time to time will be applicable in deciding the tender. All correspondence regarding the tender process will be communicated by registered post/ e-mail address. All are requested to check the e-mail from time to time regarding the tender. No claim whatsoever will entertained for non-receipt of communication in hard copy.
30. Bids received online shall be opened **(Cover-I)** in the office of the undersigned on **dtd. 09.11.2020** at **11.00 AM**. If the office happens to be closed on the date of opening as specified, the bids will be opened on the next working day at the same time and venue.
