NATIONAL COMPETITIVE BIDDING THROUGH e-Procurement

Invitation For Bids (IFB) IFB No. EEPHPURI- 45 Dt.19.11.2020

The Executive Engineer, P.H. Division-Puri, Tender Inviting Authority (TIA) on behalf of Governor of Odisha invites **Percentage Rate Bids** through e-Procurement in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) in Two Bid system (Part-I: General & Technical Bid and Part-II: Price Bid) from **"B" Class" & "A" Class Contractors** registered with the Odisha State Government and Contractors of equivalent grade/class registered with Central Government/ any other State Government/ MES/ Railways and Reputed Engineering Firms having experience and expertise in execution of **Similar Type of Works** and fulfilling minimum eligibility criteria as stated hereunder and other detailed qualifying requirements given in the DTCN on **"Percentage Rate Basis"** to be eventually drawn up in the standard **P1 Contract Form**. The bid should be submitted on-line in the website <u>www.tendersorissa.gov.in</u> by eligible class of contractors. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). Contractors register elsewhere but not registered with Government of Odisha can also participate in the e-procurement after necessary enrolment in the portal but have to subsequently register themselves with the appropriate registering authority of the State Government before award of work / signing of the Agreement as per prevalent registration norms of the State.

- 2. Mode of Submission of tender: Tender should be submitted online in www.tendersorissa.gov.in
- 3. The bidders desirous to participate in bidding must possess compatible Digital Signature Certificate of Class-II or Class-III and should follow the changes / modifications / addendum to DTCN if any.
- 4. a) The bidder should be make payment through online receipt towards Tender Paper Cost and EMD. No off line receipt of Tender Paper Cost and EMD will be allowed in e-procurement portal of Government of Odisha.

b) The scanned copy of Registration certificate, GST, PAN, affidavits including all required papers up loaded through website should be produced in original to **Executive Engineer**, **P.H. Division**, **Puri**, **Odisha** for verification within three days of opening of Bid. Otherwise the tender will be rejected.

6. <u>Minimum Eligibility Criteria</u>:-

- The Registered Contractors should have successfully Completed & Commissioned Works of similar type such as RCC water retaining structure i.e OGR, ESR, RCC settling tank having capacity of minimum 0.5ML valuing not less than Rs.83.49 Lakhs (30% of the estimated cost) in any one financial year during the last 5 (five) years. The firm shall have to submit the performance certificate of completed & Commissioned works constructed by them for satisfactory performance from appropriate authority i.e. not below the rank of Executive Engineer / equivalent. Weightage @ 10% per year shall be given on the value of the completed work in the preceding years.
- The Registered Contractors should have annual financial turnover of not less than Rs.111.33 Lakhs (40% of the estimated cost) in any one financial year in the civil construction works during last 5 (five) years and the turn over need to be certified by Chartered Accountant. Weightage @ 10% per completed financial year (on compound basis) shall be given on the annual turnover of the preceding years. Bidder shall furnish complete audited annual financial year statements for last five years including audit report, balance sheets, profit and loss accounts statement all other schedules etc in support of meeting the financial criteria as mentioned above.
- 7. The bid for the work shall remain open for acceptance for a period of **120 (One Hundred Twenty) days** from the date of opening of price bids. If any Bidder / Tenderer withdraws his bid / tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
- 8. Other details can be seen in the bidding documents, which is available in website www.tendersorissa.gov.in.

- The Bidder should have not been black listed by the Govt. / Govt. undertaking 9. on the bid opening date. Self-declaration certificate by bidder in the form of affidavit is to be submitted
