The Project Engineer, PMU-I, OWSSB, Sambalpur on behalf of Governor of Odisha invites **Percentage Rate** bids in **Single Cover System** for the construction of work as detailed in the table, from the class of eligible contractors as mentioned in column-5 (five) registered with the State Governments and Contractors of equivalent Grades/ Class Registered with Central Government/ MES/ Railways for execution of Civil Works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government has to register under the state PWD in appropriate class of eligibility before signing of the agreement.


4. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class II or Class III.
5. Bids shall be received only "**On-line**" on or before **17:00 Hours of 17.11.2020**.
6. Cost of Bid Documents, EMD/Bid Security, Original Affidavit(s) and other original documents as mentioned in this DTCN are to be submitted up to **17:00 Hours of 20.11.2020**.
7. Bids received "on-line" shall be opened at 11:30 Hours on 21.11.2020 in the office of the Project Engineer, PMU-I, OWSSB, Sambalpur, Odisha in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
8. The cost of bid documents as mentioned in Column 7, the bidders shall submit in original in shape of demand draft drawn in favour of the Project Engineer, PMU-I, OWSSB, Sambalpur on any nationalized/ schedule bank in India, payable at Sambalpur.
9. Rate quoted by the contractor shall be excluding GST.
10. The successful bidder who has quoted less bid price / rate than the estimated cost put to tender shall have to furnish exact amount of differential cost i.e. estimated cost put to tender minus quoted amount as **additional performance security (APS)** in the shape of NSC/Term Deposit/Fixed Deposit/Post Office Time Deposit/ KVP drawn/pledged in favour of the **Project Engineer, PMU-I, OWSSB, Sambalpur**.
11. Detailed **information** as contained in the D.T.C.N. shall have to be strictly adhered to while submitting the tender papers
12. **Engineer Contractor** desirous to avail the facility of **exemption of E.M.D.** is required to submit **an affidavit in original** to the effect that he has not yet availed the facility for more than two works during the current financial year. The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing which the tender will be rejected.
13. Other details can be seen in the bid documents.
14. This notice is to be read with all the Clauses/ addendum to the "Procedure to participate in online bidding".
15. If any of the intending bidders wish to withdraw from participation in the bid, he/she can freely **withdraw** from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant codal practice will be taken against him/her.
16. Any corrigendum / Addendum will be displayed in the website **www.tendersodisha.gov.in** only.
17. If the office happens to be closed on the opening day due to subsequent declaration as holiday in Govt. or local authority the tenders will be opened on the immediate next working day at same time and venue respectively.
18. The online bidder shall have to produce the original documents for verification in support of scanned copies and statements uploaded in the portal within three days from the date of opening of the bid.
19. Conditional tender will be summarily rejected. The Department reserves the right to reject any or all bids without assigning any reason thereof.
