The bidder who have quoted less bid the Additional Performance Security in shape of Term Deposit Receipt / Bank Guarantee of any Nationalised / Scheduled Bank in India counter guaranteed by its local branch duly pledged in favour of EE, NH Division, Bolangir (if applicable) shall be furnished by the successful bidder within seven days of issue of Letter of Acceptance (LoA) by the EE NH Division, Bolangir, failing which he / she shall be black listed from the department along with the forfeiture of EMD / Bid Security as per OM No. 14459, dt.20.09.2018 of Works Department, Govt. of Odisha.
