12. The cost of tender paper and EMD as indicated above shall be received online along with the bids as per guideline issued by Works Dept O.M No 6785 dated 09.05.2017 and No 17254 dated 05.12.2017. The procedure of bid submission using electronic payment of tender paper cost and EMD by the bidder may be referred in Works Dept O.M No 17254 dated 05.12.2017 which has been added to the DTCN.
13. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
14. Bids received online shall be opened in the office of Executive Engineer, M.I. Division, Jashipur on **22.12.2020 at 11.00 A.M.**

16. Engineer contractor who wants to avail EMD Exemption shall have to furnish scan copy of affidavit along with tender, declaring there in that he/she has not yet availed three Nos. of EMD Exemption during this financial year and to show the original registration certificate to the tender opening authority for verification without which the tender will be rejected. SC/ST contractors desires of availing benefit as per works Department resolution No 27748 dated 11.10.1977 must submit affidavit for the same alongwith attested copy of caste certificate.
17. A bidder has to deposit 2% EMD / Bid Security of the amount put to tender rounded off to the nearest one hundred rupees, if he/she proposes to engage machineries and equipments as asked for in the tender documents, owned or hired but deployed outside the state
18. **"Additional performance security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of N.S.C/P.O.T.D/K.V.P/Fixed deposit receipt of scheduled bank pledged in favour of Executive Engineer M.I Division, Jashipur/ Bank Guarantee in favour of Executive Engineer M.I Division, Jashipur from any Nationalized/Schedule Bank in India counter guaranteed by its local branch at Bhubaneswar within seven days of issue of Letter of Acceptance (LoA) by the Divisional Officer (By email) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/Bid Security shall be forfeited. Further proceeding for blacklisting shall be initiated against bidder". The Bidders must provide their valid email id to which issue of Letter of Acceptance will be sent from the email id i.e. eemijashipur@yahoo.com.**
19. Copy of **valid GSTIN, PAN, LICENSE & Affidavit for Authentication of documents** shall be uploaded along with the tender documents for considering the tender, else the tender will be rejected.
20. As per Para-12.4,Para-12 in Appendix-IX(A) of OPWD Code Volume-II as follows:- 'Registration in the Contractors Data Base Management System(CDMS) available at www.cdmsodisha.gov.in by all Contractors is mandatory-"
21. GST as applicable (Presently TDS-2%) on the gross amount of the bill will be deducted from the contractors bill while making payment, where agreement value exceeds rupees two lakh fifty thousands.
22. GST on works contract as applicable at the time of payment shall be paid extra over the gross amount of the running bill amount. (vide section 15 and section 142 (11) © of Odisha goods and services Tax Act 2017).
23. Commercial invoice should be submitted by the contractor at the time of preparation of the work bill to the concerned Junior Engineer with a copy to the Divisional Office for enabling the Division to make necessary payment, failing which no GST payment can be made.
24. All the existing provisions of OPWD code with amendment from time to time will be applicable in deciding the tender. All correspondence regarding the tender process will be communicated by registered post/ e-mail address. All are requested to check the e-mail from time to time regarding the tender. No claim whatsoever will entertained for non receipt of communication in hard copy .
25. Agreement shall be drawn only after due verification of EMD & APS of the successful bidder. If any fake instruments are detected, Criminal proceedings will be initiated against the defaulting bidder and action will be initiated for blacklisting through the license issuing Authority.
26. Bid documents consisting of qualification information and eligibility criterion of the bidders, plans, specification, drawings and abstract of various classes of work is available in Website www.tendersodisha.gov.in. during the bidding period.
27. Bid for the work shall remain open for acceptance for a period of Ninety days from the last date receipt of Bids. If any Bidder/ Tenderer withdraw his/her Bid /tender before the said period or makes any modifications in the terms and conditions of the Bid, his/her earnest money shall stand forfeited.
28. 1% (One Percent) of gross bill of the bidder will be deducted towards labour cess- over and above the usual deduction.
29. If the rate quoted by the bidder is less than 15 % of the tendered amount then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99 % (Decimals up to two number will be taken for all practical purpose) less than the estimated cost the tender accepting authority will finalize the tender through a transparent lottery system where all bidders/their authorized representatives the concerned Executive Engineer & DAO will remain present as per amendment to appendix-ix, clause-36 of OPWD code vol-II.

30. The bidder must provide the mobile No and e-mail ID along with the tender documents for official correspondence, if any. No paper correspondence shall be made in this regard to avoid delay in finalization of tender. In case of lottery need to be conducted in accordance with the works department order no.12366 dtd 8.11.2013, the same will be conducted on dt **30.12.2020 at 11.00 AM** in presence of the bidders or their authorised agents in the office chamber of Executive Engineer, M.I. division, Jashipur.
