INVITATION FOR BIDS (IFB)

The Executive Engineer, Sambalpur Irrigation Division, Sambalpur, Po-Khetrajpur, Dist-Sambalpur, Odisha, on behalf of Governor of Odisha invites **On-line percentage rate bids in single cover system through e-procurement method of bidding** for the works mentioned in the table below. The Bids should be submitted by the eligible class of contractors as mentioned below, registered with the State Governments and contractors of equivalent grade/class registered with Central Government / M.E.S./ Railways, through On-line in the Government web-site www.tendersodisha.gov.in The bidders should have necessary portal enrolment (with own digital signature certificate). The proof of registration from the appropriate authority shall be enclosed along with the bid. The registered bidders outside of Odisha State can also participate in this on-line tender process after necessary portal enrolment but shall have to subsequently undergo registration with the appropriate authority of the Odisha State Government within one month of acceptance of bid.

1. Cost of Tender Paper – The bidder shall transfer online the cost of bid document as mentioned in Column-05 of above table as part of its bid through a process as mentioned in the DTCN.
2. **E.M.D. Required :-** The bidder shall transfer online the Earnest Money Deposit / Bid Security of the amount specified for the work in the table Column-4 above as part of its bid through a process as mentioned under DTCN. Bidders desirous of hiring machineries or equipments' from outside the State or owned but deployed outside the state are required to transfer online 2% of the amount put to tender as extra bid security.

3. **Additional Performance Security:-** Additional Performance Security should be furnished by the successful bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost, i.e., estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of TDR / STDR issued by Nationalized Bank / NSC / KVP / Post office time deposit / Post office saving bank account pledged in favour of **Executive Engineer, Sambalpur Irrigation Division, Sambalpur** within seven days i.e. from the date of issue of intimation to the bidder, if the bidder fails to deposit the required APS by the schedule date and time, the bid stands automatically cancelled along with forfeiture of Earnest Money Deposit & no complaint what so ever will be entertained thereafter. Further proceeding for black listing shall be initiated against the defaulting bidder / contractor.
4. **Initial Security Deposit @ 2% of contract value shall be furnished by the bidders / bidder in shape of Term Deposit Receipt of Nationalized Bank pledged in favour of Executive Engineer, Burla Irrigation Division, Burla.**
5. Goods and Service Tax (GST), Royalty and all taxes shall be applied as per prevailing rules.
6. **Mode of Transmission of Tender:-** Tender should be submitted online in www.tendersodisha.gov.in.
7. **Period of availability of tender On-line:-** Details of followings Date & time of bidding On-line / last date of seeking clarification / date of opening of tender papers.

- N.B.** In the event, the specified date of bid opening being declared a holiday for the officer inviting the bid. The bids will be opened at the appointed time on the next working day.
8. Any addendum / Corrigendum / Cancellation of above tender will be published in the web-site. www.tendersodisha.gov.in, and in the notice board. The system shall generate a mail to those bidders who have already uploaded their tenders and those bidders if they wish, can modify their tenders.
 9. Bid documents consisting of qualification, information and eligibility criteria of bidders, plans, specification and schedule of quantities of the work are available in web-site www.tendersodisha.gov.in and the set of terms and conditions of contract and other necessary documents can be seen in the web-site till last date of sale and receipt of tender papers. Interested bidders may obtain further information at the web-site www.tendersodisha.gov.in.
 10. The bid validity period of the tender is for a period of 90 days from the last date of receipt of the bids. If any bidder/tenderer withdraws his bid/ tender before the said period or makes any modification in the terms and conditions of the bid, the Earnest Money Deposit (EMD) deposited at the time of submission of tender shall stand forfeited.

11. No Engineer of Gazetted rank of other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a contractor till a period of two years after his/her retirement from Government Service without Government permission.
12. Other details including details of Portal Registration, Submission of Bid, Resubmission and withdrawal of bid can be seen in the bidding document which is available in web-site www.tendersodisha.gov.in.
13. The bidders are indispensably required to **submit the Original Copies of Valid License / PAN CARD / GSTIN Registration Certificate / Original Affidavit and authentic proof documents towards purchase of bid documents / tender papers with in 03 (Three) days from the date of opening of the Bid** otherwise the bid shall be considered as non responsive, hence liable for rejection. Engineering contractors who are desirous availing the facility of exemption of EMD is required to submit the affidavit in original to the effect that he has not yet availed the facility for more than 03 (Three) works during the current financial year. Name of the works and authority to whom the tenders has been submitted must be mentioned in affidavit, failing which, the tender will be liable for rejection. However the original registration license of the Engineering contractor should be produced at the time of opening of tender.
14. If the 1st lowest bidder does not turn up for agreement after finalization of tender, then he shall be debarred from participation in bidding for three years and action will be taken to blacklist the contractor.
15. The bidders shall furnish an affidavit at the time of submission of the bid, about the authentication of the tender documents including Registration Certificate, PAN Card, Valid GST clearance certificate and security etc. failing which the bid shall be considered as non-responsive and thus liable for rejection. No adjustment of EMD will be entertained at all under any circumstance. Labour license is to be produced by the successful bidder at the time of agreement.
16. Amendment to Para 3.5.18 of OPWD code vol-I & rule-29 of Appendix-IX of OPWD code Vol-II "The single tender received in 1st call shall be cancelled without opening of the bid & fresh tender will be invited" as per Office Memorandum No. 16 dated. 01.01.2015 of Works Department Govt. of Odisha and as per "Works Department O.M. No. 16, dated. 01.01.2015 implies that single tender received in the first call shall be cancelled without opening of bid and in case when more than one tender have been received in the first call and only a single tender is found to be responsive, the same is also liable to be cancelled due to lack of competitive price bidding. (Vide Letter No. 4410 dt. 19.02.2018 of DoWR & Memo No. 4714 dt. 13.02.2018 of the E.I.C., W.R., Bhubaneswar.
17. Exemption of E.M.D. to Engineering contractors are to be governed as per Works Department letter No. 6315 dt. 16.06.2011.
18. Bidders must furnish their present **e-mail address** / detail address and Tele Phone No./ Mobile No in the separate sheet for communication regarding the tender.
19. The works performance of bidder under this division with respect to completion of previous projects within stipulated time will be taken in consideration while evaluating the bid.
20. The bidder to submit a list of works on hand at the time of submission of Tender papers. This will be taken into account while evaluation of tenders.
21. As Goods and Service Tax has come into force with effect from **01.07.2017**, GST as applicable will be paid extra after gross bill amount prepared vide Section-15 and Section-142 (11-C) of Odisha Goods and Service Tax Act-2017.
22. Other details can be seen in the bidding documents, which is available in web-site www.tendersodisha.gov.in.
23. **The authority will not be held responsible for any technical problem / failure of network / Malfunction or Interruption of server during the schedule dates of online bidding.**

24. The authority reserves the rights to reject any or all the tenders without assigning any reason thereof.
25. The bidder must provide his/her authentic Mob No./Tel. No. & E-mail id/Saving Account No. or current Ac. No. nationalized bank with IFSC code.
