15. The Contractors who have more than three works pending under this Division and who has not completed the work in time and contract has been closed or recommended for closer with penalty under this Division at the time of bidding are not eligible to participate in the present tender.
16. The estimated cost put to tender is exclusive of GST as applicable.
17. Affidavit and supporting documents towards claim of exemption of EMD etc should be uploaded along with the tender documents failing which such claim shall not be considered.
18. The intending renderers should visit the site before tendering and should be prepared with required machineries to complete the work by the scheduled date of completion.
