NATIONAL COMPETITIVE BIDDING THROUGH e-Procurement

The Executive Engineer, R.W.S&S Division, Sundargarh on behalf of Governor of Odisha invites tender on **Percentage rate basis** through **e-Procurement** in conformity with the terms and conditions mentioned in Detailed Tender Call Notice (DTCN) in Single bid system as stated below from **the eligible Contractors as mentioned in Cl.No.5** registered with the Odisha State Government and Contractors of equivalent grade/class registered with Central Government/ any other State Government/ MES/ Railways and Reputed Engineering Firms with experience in similar nature of works and fulfilling minimum eligibility criteria as stated here under and other detail qualifying requirements given in the DTCN on **“Turnkey Basis”** to be eventually drawn up in the standard P1 Contract Form. The bid should be submitted on-line in the website **www.tendersodisha.gov.in** by eligible class of contractors. The bidders should have the necessary Portal Enrolment with his own Digital Signature Certificate. The registered bidders of outside Odisha can also participate in this process, after necessary Portal Enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Government before signing agreement.

- Mode of Submission of tender: Tender should be submitted online in **www.tendersodisha.gov.in**
- The bidders desirous to participate in bidding must possess compatible Digital Signature Certificate of Class-II or Class-III and should follow the changes/ modifications/ addendum to DTCN if any.
- The scanned copy of Registration Certificate, VAT/GSTIN, PAN, Experience certificate as per DTCN, Affidavits, EMD & Tender Paper Cost(payment mode-online) including all required paper are to be uploaded through website .
- Engineer contractor desirous to avail the facility of exemption of EMD is required to submit an affidavit (scan copy) to the effect that he has not yet availed the facility for more than two works during the recent financial year 2020-21. The name of work for which and the authority to which the tender is being submitted on-line must be mentioned in the affidavit failing which the tender will be rejected.
- Original Bid security and Demand Draft towards cost of bid document must be submitted on-line mode before **16.01.2021 up to 5.00 P.M** failing which the bid will be rejected.
- However APS need to be deposited off -line in shape of Terms deposit receipt (TDR) in favour of Executive Engineer, RWS&S Division, Sundargarh if the quoted bid is less than the tender amount as well as ISD also deposited offline in shape of TDR in favour of Executive Engineer, RWS&S Division, Sundargarh at the time of drawal of agreement.
