**EXPRESSION OF INTEREST (EOI)**

**EOI for Empanelment of Consultancy Firms/Agencies for Preparation of Detailed Project Report (DPR) of Piped Drinking Water Supply Schemes in Rural Areas of Odisha**

The Engineer-in-Chief, RWSS, on behalf of the Government of Odisha in Panchayati Raj Department invites Expression of Interest (EOI) from established Consultancy Firm/ Agencies having experience in providing consultancy services in the field of piped drinking water supply projects for empanelment (for a period of 3 financial years under Rural Water Supply & Sanitation (RWSS) to carry out the work of preparation of DPR for piped drinking water supply schemes.

The process of procurement of services of firms/agencies for Preparation of the Detailed Project Report (DPR) shall be as follows:

1. The above work of Preparation of DPR has been divided into 4 broad categories i.e. **Category-A** (Project Costing above Rs. 200 crores), **Category-B** (Project Costing above Rs. 50 crores and below Rs. 200 crores), **Category-C** (Project Costing above Rs. 5 crores and below Rs. 50 crores) and **Category-D** (Project Costing above Rs. 0.50 Crores and below Rs. 5 crores).
2. The interested firms/agencies shall submit the Expression of Interest for empanelment in any one or more categories mentioned above.
3. The firms/ agencies who meet the eligibility criteria for any one or more category as per specification of the Detailed EOI document shall be category-wise empanelled with the Rural Water Supply & Sanitation (RWS&S), Odisha
4. The upcoming projects for rural water supply shall be categorised into any of the four category mentioned above and the empanelled firms/agencies listed within the category shall be invited to submit their detailed technical & financial proposal.


