**NOTICE INVITING TENDER**

1. The Government of India has received a loan from Japan International Cooperation Agency (JICA) towards the cost of Odisha Integrated Sanitation Improvement Project (II), ID-P252. It is intended that part of the proceeds of this loan will be applied to eligible payments under the Contract for Construction of Box Drains with Road between Chainage 3300 – 5150 of Main Drain - 1, Cuttack, Design Build – (Package No. JICA/OWSSB/OISIP/04 – II/ LOT 1) and Construction of Box Drains with Road between Chainage 5150 – 6700 of Main Drain - 1, Cuttack, Design Build – (Package No. JICA/OWSSB/OISIP/04 – II/ LOT 2).
