- 1. The intending tenderer are hereby advised to obtain the information of auction vehicle and tender application from the Govt. website as mention in the notice and inspect the condemned vehicle kept in office of the Assistant Executive Engineer, Sakhigopal Irrigation Sub-division, Sakhigopal well in advance before submitting the sealed tenders. Submission of sealed tender will be taken as sufficient prove of the tender to have inspected the vehicle put for sale and no further complain regarding the condition of the vehicle will be entertained on any circumstances. The auction sale of the condemned vehicle are done as is where is basis
- 2. The intending tenders will have to submit as earned money of Rs. 1,500/-(One thousand five hundred) only against the vehicle in shape of Demand Draft/ Postal saving Account/ Bankers cheque in favour of Executive Engineer, Puri Irrigation Division, Puri payble at S.B.I Main Branch, Puri along with the sealed tender. Tender papers without EMD in shape of Bank Draft/ Bankers Cheque/ will be rejected.
- 3. All the tenders received will be opened in the presence of the tenderer or their authorized agents if they are present at 4.30PM on dated 22.01.2021 in their absence the tender application received from them will treated as cancelled/ If the date of tender is declared as a govt. Holiday the tenders will be opened in the next working day as per the schedule time. Delay in postal delivery shall not be taken in account. - 4. Tender with highest offer of BID amount shall be accepted and such tenderer shall have to deposit 25% of the accepted highest tender amount immediately on the spot and rest 75% within 15days. From the date of issue of ratification order or confirmation of the tender. The highest tender below the upset price will be referred to the competent authority for decision.
- 5. In case the highest tenderer fails to deposit the balance 75% amount within the stipulated period from the date of ratification order/confirmation of tender 25% of the tender amount including caution amount deposited on the date of opening of the tender will be forfeited to Govt. and the vehicle will be sold by fresh auction.
- 6. The vehicle shall not be delivered to the highest tenderers till full payment is made and other formalities are fulfilled.
- 7.
