1. The Executive Engineer, Kandhamal Minor Irrigation Division, Phulbani on behalf of Governor of Odisha invites **Percentage rate bids in single cover system only in "ON LINE" mode** for works detailed in the table from "D" & "C" Class & above class Contractors registered with the State Government and contractors of equivalent Grade/Class registered with Central Government /M.E.S/ Railways for execution of civil works on production of definite proof from the appropriate authority. The bidders may submit bids for any or all of the following works.

2. Bid documents consisting of plan, specification, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the website: www.tendersodisha.gov.in
3. Bids must be accompanied by a **non-refundable fee** as indicated at **Column-6** of Annexure towards **cost of Tender Paper** and the amount specified at **Column-5** as **Earnest Money Deposit/ bid security** for the works. **The cost of Tender Paper and Earnest Money Deposit/ bid security are to be remitted online as per instruction issued in Works Department office Memorandum No.17254 dated 5.12.2017 (Copy appended).** The Bidders desire to hire machineries or equipments from outside the state or owned but deployed outside the state are required to furnish 2% of the amount put to tender as Bid Security. Only those bidders who successfully remit their cost of Tender Paper and Earnest Money Deposit on submission of bids would be eligible to participate in the tender/ bid process. The bidders with pending of failure payment status shall not be able to submit their bid. Tender inviting authority, State Procurement Cell, NIC the designated Banks shall not be held responsible for such pendency or failure.
4. Bidding documents can only be available on-line in the Government of Odisha website <http://www.tendersodisha.gov.in> from **22.01.2021 to 01.02.2021** up to 16.00 hours for preview, download & submission
5. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class-I & Class-II.

6. Bids received online shall be **opened at 11.00 Hours on 02.02.2021** in the office of the undersigned in presence of the bidders who wish to attend. Bidders who participated in the Bid can witness the opening of Bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
7. A bidder shall not be permitted to bid for works in the M.I Organization responsible for award and execution of contracts in which his or his spouse's near relative (defined as first blood relations, and their spouses) is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer & Junior Engineer(both inclusive).
8. The online bidders should upload the scan clear copy of the affidavit in support of correctness or proof of the information submitted including bid security accompanied with tender by them.
9. Engineer Contractor desires to avail the facility of exemption of E.M.D. is required to submit an affidavit to the effect that he has not yet availed the facility for more than two works during the current financial year. The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing which he will be not entitled to get any facility. Similarly ST/SC contractors seeking exemption of 50% E.M.D. or price preference are required to produce an affidavit to this effect. The ST/SC contractors having Degree/Diploma in engineering are not allowed to avail both the benefits. **Both Engineering and ST/ SC contractors should submit the affidavit in writing regarding the facility to concerned Officer inviting tender; otherwise they will not be entitled to get the facility.**
10. The bidder should not quote in any tender 15% less than the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids.
11. **Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidders who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security in shape of N.S.C., Postal Saving Bank. Pass Book, K.V.P. Post Office Time Deposit Receipt & Deposit receipt of any Nationalized/ Schedule Bank duly pledged in favour of the Executive Engineer, Kandhamal, Minor Irrigation Division, Phulbani within seven days otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further proceeding for blacklisting shall be initiated against bidder.**
12. Goods and Service Tax (GST) will be imposed as applicable
13. Any Corrigendum/ Addendum will be displayed in website <http://tendersodisha.gov.in> **only**. It is the bidder's responsibility to verify the web site for latest information/ corrigendum related to the bid.
14. Conditional tender will summarily be rejected.
15. The bidders subject to be disqualified, if they have record of poor performance, such as abandoning the work, not properly completing the previous contract with the organization inordinate delays in completion other projects, litigation history or financial failures.
16. If any bidder backs out from the bidding process or make any request for alteration or modification in terms and condition of the bid shall debar the bidder from participating in the online bidding system and his portal registration shall be blocked including recommendation to registering authority for cancellation of his registration as contractor including forfeiture of bid security deposited.
17. Quality control tests as per specification for all items of the work executed will be taken in nearly Govt. Quality Control Laboratories of Minor / Medium/ Major Irrigation Organisation. It is binding on successful bidder to extend all necessary support in getting the tests done till completion of the work in all respect.

18. **It is mandatory that the Bid should be accompanied with the scanned copies of the valid Registration Certificate, Valid CDMS, valid GSTN, PAN Card, No relation certificate, Affidavit for authenticity of documents with residential proof for official correspondence, Valid Mobile No. email Id, WhatsApp No. and other requisite documents as per the Bid Document.**
19. **The bidder should not unnecessary documents except required documents as mentioned above.**
20. **The affidavit to be submitted in legal stamp paper individually for each work by the bidder failing which the bid will be rejected.**
21. **The Successful bidder will furnish Bank contact details (Bank Address & e-mail ID) along with APS to verify the authentication of TDR/STDR/NSC/ Postal Saving Pass Book/ POTD receipt/KVP.**
22. **The work which is meant for the current financial year has to be completed within the current financial year, as the allotment for the same will lapse during the current financial year, afterwards no claim for payment of the work bill will be entertained.**
23. Since the works are of very urgent in nature hence non drawing of the agreement within 07 days from finalization of tender; it will be automatically cancelled with forfeiture of EMD as per codal provision.
24. The eligible bidders whose quoted rate is 14.99% less than the estimated cost put to tender and the eligible price preference bidders comes to 14.99% less will attend the transparent Lottery system on dated **09.02.2021 at 11.00 AM**. If the office happens to be closed on the scheduled date of lottery, then the lottery shall be conducted on the next working day at the same time and venue. No further correspondence shall be made in this regard.
25. The authority reserves the right to reject any or all Bids without assigning any reason.
