6. Minimum Eligibility Criteria :-

The bidder has to satisfy all of the following criteria failing which the bid will summarily be rejected.

- i) The Bidder shall be the Registered Manufacturers / Authorized Dealers / Authorized Distributors of Silent Diesel Generator Sets of different capcity /Electrical Contractors having valid H.T. / M.V. license. The Authorized Dealers / Authorizes Distributors should have Dealership / Distributorship association with the manufacturer more than one (1) year before bid due date. Registered Manufacturer / Authorized Dealer / Authorized Distributor should have their local office in Odisha.
- ii) The Bidder shall have supplied, installed, tested & commissioned at least 2 (Two) Nos. of Silent DG sets with AMF panel of similar capacity (range from 100 KVA to 400 KVA or above) power output rating within the period not greater than Five (5) years and not less than one (1) year reckoned from the bid due date.
- iii) Manufacturers / Firms/ Electrical Contractors having valid H.T / M.V. license shall have to submit written commitment as regards to availability of spare parts for maintenance of supplied silent diesel generator set with AMF panel for 10 (Ten) years after successful commissioning of the same.
- iv) The Bidder shall furnish the following documents:
 - (a) Written commitment from manufacturer of the Silent Diesel Generator sets with AMF panel.
 - (b) Written back-up guarantee letter obtained from the Manufacturer of the Silent Diesel Generator sets (with different capacity.
 - (c) Manufacturers Test Certificated, Guarantee/Warranty & other relevant documents for each DG sets.

(d) Declaration letter of Manufacturer of the DG sets or their Authorized Firms that they shall be present at site during installation, testing for successful; commissioning & safe operation of the DG sets.

v) For qualification of the bidder, the above clauses shall be read in conjunction.

6.1.1 Documents Required

Bidder shall submit the following documents to establish that the bidder meets the qualification requirements as per clause No.6.1 above of this document:

- (a) Duly completed Bidder Proven Track Record Pro-forma as enclosed with the bid document, together with all back-up documents specified therein.
- (b) Documents as per clause No.6.1 (iii) for all the offered DG sets.
- (c) Authorized Dealers or Authorized Distributors Certificate from the Manufacturer of the Silent Diesel Generator sets with different capacity.
- (d) Documentary evidence like copies of Purchase Order, Inspection release note (IRN), Approved Drawings & Data sheets and commissioning or completion certificate as an evidence of meeting PTR requirements {as per 6.1.1 (a)above}, based on which qualification is sought.
- (e) General reference list for the proposed equipment.

6.2The Bidder (Registered Agency / Firm / Manufacturers / Electrical Contractors having valid H.T. / M.V. license) should have annual turnover of not less than Rs.21.49 (40% of the estimated cost) in any one year in "Supply, installation, testing and commissioning" of (a) HT / LT Diesel Generator Sets, or (b) HT / MV Electrical Infrastructure works during last 5 (five) years and the turn over need to be certified by Chartered Accountant (Only item No.1) Weightage @ 10% per year shall be given on the annual turnover of the preceding years.
