The **General Manager, WATCO Division-I, Bhubaneswar** on behalf of Governor of Odisha invites **Percentage Rate Bids** through **e-Procurement** in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) in Two Bid system (Part-I: General & Technical Bid and Part-II: Price Bid) from Registered **Manufacturers / Authorised Dealer/Distributor with Joint venture** having experience and expertise in Installing, Testing & Commissioning of Similar Type of Works and fulfilling minimum eligibility criteria as stated hereunder and other detailed qualifying requirements given in the DTCN on "turnkey basis" to be eventually drawn up in the **Standard P<sub>1</sub> Contract Form of Odisha PWD**. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). **The registered bidders of outside Odisha can also participate in this process,** after necessary enrolment in the appropriate authority of the State Government before award of work / signing of the Agreement.

### 6. Minimum Eligibility Criteria:-

- i) The Manufacturers / Authorised Dealer/ Distributor with Joint venture should have successfully Completed & Commissioned Works of similar type valuing not less than Rs.15.54Lakh (30% of the estimated cost) in any one financial year during the last 5 (five) years. However, such similar type of work must cover supply & installation of VT/Centrifugal pump with 3.3HT motor. The Manufacturers / Authorised Dealer/ Distributor with Joint venture shall have to submit the performance certificate of the Supply & installation by them for satisfactory performance from appropriate authority i.e., not below the rank of General Manager /equivalent. Weightage @ 10% per year shall be given on the value of the completed work in the preceding years.
- ii) The Manufacturers / Authorised Dealer/ Distributor with Joint venture should have annual financial turnover of not less than Rs.20.72 Lakh (40% of the estimated cost) in any one year in Supply & installation during last 5 (five) years and the turn over need to be certified by Chartered Accountant. Weightage @ 10% per year shall be given on the annual turnover of the preceding years.

## 7. Escalation Factor (On Compound basis):

Following enhancement/compounding factors will be used for the costs of works executed and the financial figures to a common base value.

- 8. To arrive at the value of completed works, Value of multiple contracts executed in a financial year shall be consider. For this purpose, the Completion certificates given by the authorities for any one financial year shall be consider. In case value of works executed in any one financial year is not available in the Certificates, the same shall be calculated on a pro-rata basis, considering that the total completed value and the time schedule in days.
- 9. The Bidder should have not been black listed by any Govt./ Govt. Undertaking on the bid opening date. **Self-declaration certificate** by Bidder in the form of Affidavit is to be submitted.
- 10. The bid for the work shall remain valid for a period of 120 (One Hundred Twenty) days from the date of opening of Price Bid. If any Bidder/ Tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
- 11. Bids from Consortium/ Unincorporated Joint Venture is not acceptable.
