VICE CHANCELLOR OF KALAHANDI UNIVERSITY (BHAWANIPATNA, ODISHA)

Applications are invited from eligible candidates (academicians of repute with adequate administrative experience) below 63 years of age (as on 1st March 2021, i.e. born after 01.03.1958) for the position of Vice-Chancellor of Kalahandi University*, Bhawanipatna, Odisha. The applicant should be a distinguished academician of proven academic and administrative excellence and a well-rounded personality with a minimum of 10 years of experience as Professor in a University system or 10 years in an equivalent position in reputed research and / or academic organization.

The post carries a pay of Rs. 2,10,000/- (Rupees two lakhs and ten thousand) with Special Allowance of Rs. 5000/- per month and other usual allowances. The tenure of the Vice-Chancellor will be four years from the date he/she assumes office or till he/she attains 67 years of age; whichever is earlier.

The applicants are required to apply in the prescribed application proforma through e-Mail attachment (only in pdf format) to our e-Mail ID (hedsec.od@nic.in) mentioning "Application for the post of Vice-Chancellor of Kalahandi University" as the subject of the e-Mail. 


