1. The envelope carrying the bid must be super-scribed in capital with "OFFER FOR AUCTION SALE NOTICE OF VEHICLE"
2. The intending bidders are advised to inspect the above vehicles parked in the campus of JICA Office Building at Unit-8,Delta Square,Bhubaneswar-12 and CE,JICA Office ,Sukinda respectively , between 11.00 AM to 5.00 PM on any working day before submitting the tender. Each tender must accompany an earnest money deposit mentioned against the vehicle in the table in shape of National Savings certificate/Post Office Savings Bank Account/Post office term deposit account/deposit receipt of any Nationalized/Scheduled Bank only duly pledged in favour of the Executive Engineer, Left Canal Division No III, At/Po: Duburi, which will be refunded to the tenderers, whose tenders are not accepted except in case of the successful bidder. The bid price offered shall not be less than the minimum (offset) price as mentioned above. The bidder should mention in the tender regarding the desired Vehicle No. /Model / Make for which participated.

The bids must be delivered in the drop box having **Auction Sale Notice No: EE LCD - III- 01 /2020-21** in the office of the Executive Engineer, Left Canal Division No III, At/Po: Duburi, between 11.00 AM of 17.02.2021 and 3.00 PM of 03.03.2021 at the latest and tenders received shall be opened by the undersigned on date 04.03.2021 at 11.00 AM in the presence of the tenderers or their authorized representatives. If this day is declared as a Government holiday, the tenders will be received and opened on the next working day as per the scheduled time. The undersigned will not be held responsible regarding late submission/receipt of tender in any manner.
4. The highest bidder whose tender is accepted shall deposit immediately 25% of the offered amount then & there as initial deposit. He shall deposit the balance amount within seven days of the deposit of the initial amount. In case, he fails to make deposit of the total amount as per the tender within the stipulated time, the deposit including the earnest money shall be forfeited. The EMD of successful bidder can be adjusted at the time of final payment of tender value in time. Tax will be deduct as applicable
5. The successful bidder shall take permission and remove the vehicle from the place of parking within thirty days of deposit of the bid amount. On failure to remove the vehicle within the aforesaid time span, ground rent @ 1% of the tendered amount shall be charged for each day or part of the day till removal of the vehicle from the aforesaid place. If the ground rent so charged, exceeds the sale price deposit, then the tenderer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent. Tools implements of spare parts shall not be delivered with vehicle.
