12. Works will be taken up as per the availability of Funds.
13. Additional Performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. letter of Acceptance (LoA) by the Divisional Officer (by e-mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/Bid Security shall be forfeited. Further, processing for blacklisting shall be initiated against the bidder.
