E-Procurement Notice (Invitation for Bids )

The Executive Engineer, Minor Irrigation Division, Deogarh on behalf of the Governor of Odisha invites on-line **Percentage Rate** bids through e-procurement for the following Civil Construction works as detailed in the Annexure from the eligible Class of Contractors registered with the State Government of Odisha & Contractors of equivalent Grade / Class registered with Central Govt./ MES/ Railways/ CPWD on production of definite proof from the appropriate authority to be eventually drawn up in P-1 contract. The bidders may submit their bids for the following work(s) on-line in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in).

The bid documents will be available on-line in above website from on **15.02.2021 10.00 Hrs to 26.02.2021** up to 17.00 Hrs for 'On-line bidding'. The bidders must possess compatible digital signature certificates (DSC) of Class-II or Class-III to participate in the on-line bid.

**TERMS AND CONDITIONS**

1. Bids must be accompanied with required Tender paper Cost/ Earnest Money Deposit (EMD) amount specified for the work online as detailed in the DTCN. Without which the tender is liable for rejection. The copy of such deposit shall be scanned and uploaded along with the online tender.

2. Other details about this tender can be seen from the Bidding documents which is available in Website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in).

3. Engineer contractors who want to avail EMD exemption have to submit one affidavit with tender declaring therein to the effect that they have not yet availed 3 (three) nos of EMD exemption during the current financial year and to show the original Registration Certificate to the tender opening authority for confirmation at the time of opening.

4. Additional performance security shall be obtained from the successful bidder when the bid amount is less than the estimated cost put to tender. In such an event, the bidder who have quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security in shape of Term Deposit Receipt/ NSC/ KVP duly pledged in favour of the Divisional Officer at the time of execution of contract agreement.

5. The Bid documents should be up-loaded by the Bidders on-line in [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) by 17.00 Hrs on **26.02.2021** accompanying the scanned copies of On-line deposit receipt of cost of tender paper/ EMD, Valid Registration certificate, GSTIN certificate, PAN card, Labour license, No relation certificate & affidavit in proper format as per Annexure-'A' provided in the DTCN about the authenticity of the tender documents failing which the Bids will be rejected. The Bids will be opened on **01.03.2021** at 11.00 Hrs.

6. If the rate quoted by the bidder is less than 15% of the amount put to tender, then such a bid shall be rejected out rightly and the tender shall be finalized basing on the merits of rest of the bids. But if more than one bid is quoted at 14.99% (Decimals upto two numbers will be taken for all practical purposes) less than the estimated cost, the tender inviting authority will finalize the tender through a transparent lottery system, where all bidder/ their authorized representatives, the concerned Executive Engineer and DAO will remain present as per Memorandum No. 12366 dated *DGR-08/2019-20* of 08.11.2013 of Works Department, Govt. of Odisha.

7. After opening of the bid, the list of the successful Lowest/Winning bidder will be published in the e-procurement portal. The originals of scanned documents will be verified by the tender accepting authority and execute of the Contract agreement on deposit of the ISD/APS if any as per codal provisions within 07 (Seven) working days of the Publication of the list of successful Bidder.

8. Bid for the work shall remain open for acceptance for a period of 90 (Ninety) days from the last date of receipt of Bids. If any Bidder/ Tenderer withdraw his Bid/ tender before the said period or makes any modifications in terms & conditions of the Bid, the Earnest Money Deposit (EMD) shall stand forfeited.

9. No Engineer of Gazetted Rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department in State Government is allowed to work as contractor for a period of two years after his retirement from Government Service without Government permission.

10. The contractor should have registered his/her name in **Contractors Database Management System (CDMS)** irrespective of tender amount in concurrence to Letter No.30613, dt.22.07.2019 of Engineer- in-Chief(Civil), Odisha,Bhubaneswar. Non registration in CDMS portal is liable for rejection of the tender.

11. The on-line bidding process shall be Governed by e-procurement guide line of Govt.of Odisha vide Works Deptt. No. FAR- 3/08-1027/W dt. 24.01.2009 and to its amendments & relevant clauses of the OPWD code in-force.

12. Guidelines laid down in office memorandum No.7885 dated 23.07.2013 and 12366 dated 08.11.2013 of Govt. of Odisha, Works Department and to its amendments to be followed scrupulously for online bidding system.

13. The bidder must go through the Bid Documents meticulously before up-loading the tender to the web-site. The bids of the technically qualified bidders will be opened for evaluation of the price bid. Their price bid will not be taken in to consideration for evaluation even if they have qualified in the technical bid evaluation who have not complied to the Terms & Conditions as above.

15. Authority reserves the rights to reject any or all the tenders without assigning any reason thereof.
