**NOTICE INVITING TENDER e-Procurement**

Executive Engineer, Minor Irrigation Division, Bhanjanagar on behalf of Governor of Odisha invites bid for the Construction/Improvement of Minor Irrigation project & Check Dams through, e-procurement as per Annexure to this bid Notice. The bid should be submitted online in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) by **eligible Contractors**. The bidders should have necessary Portal Enrolment (with his own Digital Signature Certificate).The registered bidders of outside Odisha can also participate in this process after necessary Portal Enrolment , but shall have to subsequently undergo registration with the appropriate authority of the State Government within a month of acceptance of bid.

- The Bidder is required to furnish the requisite amount of cost of tender paper as indicated at Column-6 of Annexure towards cost of bid documents and EMD (Bid security) specified in Column-4 of the Annexure in the form as stipulated in **Works Department Memorandum No-17254 dated. 05.12.2017** (on-line payment) instead of submitting the same in shape of DD/ TDR to the undersigned earlier since the procure of submission of cost of tender paper and EMD has been amended vide the Works Department order No referred above.

- Additional performance security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidders who have quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as additional Performance Security (APS) in shape of N.S.C./ POTD/Term Deposit Receipt of any Schedule Bank counter guaranteed by its local branch at Bhubaneswar within seven days of issue of Letter of Acceptance (LOA) by the Executive Engineer duly pledged in favour of Executive Engineer, M.I. Division, Bhanjanagar within seven days, otherwise the bid shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder.
- Bid documents consisting of qualification information and eligibility criteria of the bidders, plans, specification, drawings and abstract of various classes of work is available in Website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in)
- Bid for the work shall remain open for acceptance for a period of Ninety days from the last date receipt of Bids. If any Bidder/ Tenderer withdraw his Bid /tender before the said period or makes any modifications in the terms and conditions of the Bid, the said earnest money shall stand forfeited.
- A Bidder shall not be permitted to bid for the work in the M.I. Circle responsible for award and execution of contracts in which his or her spouse's near relative (Defined as first blood relations, and their spouses) is posted as **Divisional Accountant** or as an Officer in any capacity between the grades of **Superintending Engineer** and **Junior Engineer/Assistant Engineer** (Both inclusive).
- No Engineer of Gazetted Rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department in State Government is allowed to work as contractor for period of two years after his retirement from Government Service without Government permission.

9. The Contractors, who are participating in this e-tender but not submitting the original documents such as copy of Bank proof copy towards online payment of tender paper cost, EMD, **original affidavit and other related documents such as copy of Licence, PAN, GSTIN with Mobile No. for SMS and e-mail ID** etc, otherwise will be reported to the State e-procurement Cell as well as to the higher authorities for necessary action against them.
10. The contractors who want to participate in the tender are to submit only one bid for any particular work. No extra cost towards CGST and SGST will be paid/ reimburse to the agency. The CGST & SGST amount will be recovered from the work bill as per applicable law from time to time.
11. Quality control tests as per specification for all items of the work executed will be taken in nearby Government Quality Control Laboratories of Minor/Medium/Major Irrigation Organisation. It is binding on successful bidder to extend all necessary support in getting the tests done till completion of the work in all respect at his own cost.
12. Successful tenderer will be intimated for executing agreement. The tender of SC and ST category contractor shall be finalised as per works Deptt. Resolution NO. 16262 dtd. 30.10.2018 and works Deptt. Office memorandum No. 10224 dtd. 01.09.2015.
13. The authority will not be held responsible for any technical snag or network failure during on-line bidding. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
14. The single valid tender received shall be cancelled without opening the bid in 1<sup>st</sup> call.
15. Government of Odisha Works Deptt. Office memorandum NO. 12366 dtd. 08.11.2013 should be followed scrupulously while tendering. The incomplete and conditional tenders shall be rejected. The clauses issued from time to time by the department are also applicable and mandatory.
16. Authority reserves the rights to reject any or all the tenders without assigning any reasons thereof.
