Applications are invited in the prescribed format from the intending candidates having requisite qualification and experience for filling up the honorary post of President, Odisha Bigyan Academy, Bhubaneswar under Science & Technology Department, Govt. of Odisha for a term of two year. The primary role of Odisha Bigyan Academy is to popularize science.

### 1. The eligibility criteria of applicants.

- (I) **Qualification-** Ph.D. in any branch of Science/ Engineering/ Technology or M.D.in Medical Science stream (Higher qualification is preferred).
- (II) **Age:** Maximum age 67years as on the last date of application.
- (III) **Experience:** Minimum 5 years experience in the rank of Professor or equivalent post of Central/State Government or Scientist 'F' of Research Institutes in Government of India. The candidate should also indicate the measures taken by him / her in popularizing Science (within 300 words).
- (IV) He/She should not have any adverse remark in his/her service record. He/she should not be involved in any business or politics (an affidavit in this context is required) and he/she should be in a state of good physical and mental health.
- (V) **Honorarium:** Rs.40,000/- per month.
