The bid should be submitted online in the website www.tendersorissa.gov.in by **eligible Contractors with CDMS registration**. The bidders should have necessary Portal Enrolment (with his own Digital Signature Certificate). The registered bidders of outside Orissa can also participate in this process after necessary Portal Enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Government within a month of acceptance of bid.

- Bids must be accompanied by a non-refundable fee as indicated at Column-6 of Annexure towards cost of bid documents and the amount specified at Column-4 as bid security of for the works in Annexure to this bid notice payable in favour of Executive Engineer, M.I Division, Keonjhar. Cost of bid documents and Bid security will have to be anyone of the forms as specified in the bidding documents and shall have to be valid for 45 days beyond the Bid validity.
- Other details can be seen from the Bidding documents which is available in the Website www.tendersorissa.gov.in
- Engineer contractor who wants to avail EMD Exemption shall have to furnish scan copy of affidavit along with tender, declaring there in that he/she has not yet availed EMD Exemption for three nos. of works during this financial year and to show the original registration certificate to the tender opening authority for verification without which the tender will be rejected. A bidder has to deposit 2% EMD / Bid Security of the amount put to tender rounded off to the nearest one hundred rupees, if he/she proposes to engage machineries and equipments as asked for in the tender documents, owned or hired but deployed from outside the state.
- As per Office Memorandum No. 14299 / Dtd. 03.10.2017 of Works Department, Additional Performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price / rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of Demand Draft / Term Deposit Receipt pledge in favour of the Divisional Officer (Executive Engineer) within seven days from the date of lottery, otherwise the bid shall be canceled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder. Following all codal procedure from time to time as laid down.**
- The cost of tender paper and EMD as tabulated in the annexure shall be received online along with the bids as per guideline issued by Works Dept O.M No 6785 dated 09.05.2017 and No 17254 dated 05.12.2017. The procedure of bid submission using electronic payment of tender paper cost and EMD by the bidder is as per the notification of Works Dept O.M No 17254 dated 05.12.2017 which has been added to the DTCN.**
- Bidders are advised to note the minimum qualification criteria specified in Clause-10 of the instruction to bidders to qualify for the award of the contract. Interested bidders may obtain clarifications regarding the minimum qualification criteria from the office of the Executive Engineer, M.I. Division, **Keonjhar** prior to participation in the bid.
- Bid documents consisting of qualifying information and eligibility of the bidders, plans, specification, drawings, the schedule of quantities of estimate and abstract of various classes of work is available in the Website www.tendersorissa.gov.in. As it is deposit nature of work out of DMF funding similar nature of works executed earlier timely with authenticate certificate of

completion will be added as special feature and due to time bound nature no such disproportionate progress is allowed under any circumstances what so ever may be .

8. Bid for the work shall remain open for acceptance for a period of Ninety days from the last date of receipt of Bids. If any Bidder/ Tenderer withdraw his/her Bid /tender before the said period or makes any modifications in the terms and conditions of the Bid, the said earnest money shall stand forfeited. Conditional Bid in any manner is subject to forfeiture of EMD.
9. No Engineer of Gazetted Rank or other Gazetted Officer employ in Engineering or Administrative duties in an Engineering Department in State Government is allowed to work as contractor for a period of two years after his retirement from Government Service without Government permission.
10. Clear scanned copies of tender paper cost, EMD, No relation certificate in shape of affidavit, original valid license, valid & active GST Certificate, PAN, Affidavit regarding correctness / authenticity of document for each work separately, Affidavits for claiming / availing of price preference in case of SC/ ST Contractors should be clearly indicate and mention the e-mail ID & contact no. also should be uploaded along with the Bid documents for any such immediate contact and smooth faciliation in communication facility to the concerned bidder.
11. The bidder shall have to furnish No relation certificate along with the bid documents to the effect that no officer of the Department to the rank of Junior Engineer or above is related to him.
12. The bidder quoting more than 14.99% less (decimals up to two numbers will be taken for all practical purpose) rate such bid will be rejected.
13. Further corrigendum if any can be seen from the website: www.tendersorissa.gov.in / office Notice Board.
14. GST to be imposed as applicable.
15. The bid is liable to be rejected if the TDRs submitted found fake and criminal action shall be initiated against the bidder.
16. In case of transparent lottery need to be conducted in accordance with the works department order no.12366 dtd 08.11.2013, the lottery will be held on **09.4.2021** after 11.00 AM onwards in chamber of Executive Engineer, M.I. Division Office premises. If any deviation in this due to some unavoidable / unwarrent circumstances, will be intimated as per given contact no./ mail ID / through office Notice Board for bidder information and the remaining process will be taken care in the next working day at same time and venue respectively.

It is binding on successful bidder to extend all necessary support in getting the quality control tests required till completion of the work in all respect at his own cost.
