NOTICE INVITATION FOR BIDS (NIFB)

- The Executive Engineer, U I Left Canal Division No-II, Dharamgarh, Dist: Kalahandi, on behalf of Hon'ble Governor of Odisha invites online percentage rate tenders through e-procurement for execution of the following works. The bid should be submitted by eligible class of contractors online in the Govt. website <https://www.tendersodisha.gov.in>. The bidders should have necessary portal enrolment with own digital signature certificate. The registered bidders outside of Odisha can also participate in this online tender process after necessary portal enrolment but shall have to subsequently undergo registration with appropriate authority of the State Govt. within a month of acceptance of bid. The bidders may submit online bids for the following work.



- Bid document consisting of qualification, information and eligibility criteria of bidders, plans, Specification and schedule of quantities of the works are available in web-site <https://www.tendersodisha.gov.in> and the set of terms and conditions of contract and other necessary documents can be seen in the web-site till last date of on-line bidding for the work.
- The bidder shall transfer the required amount of EMD/Bid security and cost of Bid documents as mentioned for the specified work in col. 5 and 7 respectively of the above table by online through electronic receipt mode like internet banking/NEFT/RTGS of designated banks (SBI/CICI Bank/HDFC Bank) and their aggregator banks as per Works Department O.M NO.17254/W Dt. 05.12.2017 as mentioned in DTCN. Bidders desirous to hire machineries or equipment from outside the State are required to furnish 2% of the amount put to tender as additional Bid security.
- Only those bidders who successfully remit their cost of tender paper and Earnest Money Deposit on submission of bids would be eligible to participate in the tender/bid process. The bidders with pending or failure payment status shall not be able to submit their bid. Tender inviting authority, state procurement cell, NIC, the designated Bank shall not be held responsible for such pendency or Failure.
- Bidders registered in the e-Procurement Portal <https://www.tendersodisha.gov.in> can participate in the online bidding for any or all of the work mentioned in Col. 2 of the table.


7. The bids validity period of the tender is for a period of **90 days** from the date of opening of bids if any bidder/ tenderer withdraws his bid / tender before the said period or makes any modification in the terms and condition of the bid, the EMD deposited at the time of submission of tender shall stand forfeited.
8. Bid must be accompanied with scanned copies of valid Registration Certificate, GST Registration Certificate and PAN Card failing which the bid will be rejected. Bidders desirous to avail exemption / relaxation of E.M.D. as per prevailing rules should upload copies of necessary document and affidavit in support of their claim along with their bid. Bidders registered as "**Engineer Contractors**" desirous to avail exemption of E.M.D. for participating in bid shall have to upload an affidavit for not having availed this facility in more than two works during the year **2020-21**. In such case, the successful Engineer Contractor has to produce the original Registration Certificate for recording the fact of availing exemption of E.M.D. for award of the work. Bidders registered as "**S.C. & S.T. Contractors**" desiring to avail concession(s)/ price preference as per prevailing rules should apply for the same in writing in shape of Affidavit.
9. The bidders shall have to upload an affidavit in support of authenticity of documents/ credential failing which the bid will be rejected. The authority reserves the right to verify the authenticity of documents in case of any doubt or complain.
10. **Any bidder can submit only one tender paper for a particular work. Submission of more than one tender paper by a bidder for a particular work will be liable for rejection of all such tender papers as per works department Ltr. No. 4985/W Dtd. 28.03.2007.** The bidder can download the tender of his choice and save it in his system to undertake necessary -Preparatory work off-line and upload the completed tender at his convenience before the closing date and time of submission. Resubmission of bid by the bidders for any number of times before the final date and time of submission is allowed. The Bids will be opened online on **19.03.2021 at 12 Noon onwards**, in the presence of the bidders who wish to attend. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened subsequently on the next working day at the same time and venue.
12. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering department of the State Government is allowed to work as a contractor for a period of two years after his retirement from Government service, without Government permission.
13. **All the Bidders are to provide their Mobile Number and e-mail ID at the time of online submission of the Bid for communication.**
14. The Executive Engineer, U I Left Canal Division No-II, Dharamgarh,, Dist-Kalahandi may be contacted during office hours on any working days for any further clarification between **08.03.2021 to 15.03.2021** during office hours only.

16. **Additional performance security** shall be obtained from the **successful bidder** when the bid amount is less than the estimated cost put to tender. In such an event the successful bidder shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security in shape of Post office National Saving Certificate / Post office Time Deposit Account / Kissan Vikas Patra / Term Deposit receipt/ Deposit receipt of any Scheduled Bank duly pledged in favour of Executive Engineer, U I Left Canal Division No-II, Dharamgarh Dist-Kalahandi within seven days from the date of acceptance of the tender, otherwise his/ her bid stands automatically cancelled and the security deposit shall be forfeited and proceeding for black listing will be initialized against the bidder and no complains what so ever will be entertained thereafter as per works Dept. Memorandum No. **14299/W, dated 03.10.2017** Amendment to Para-3.5.5(V) of OPWD code, Vol-I by modification. (**as per WDOM NO.17254/W Dt. 05.12.2017**)
17. Bidder has to furnish the running bill along with commerce invoice at the time of billing.
18. Statutory TDS deduction shall be made as applicable.
19. If there is more than one valid lowest bidder for any work the tender will be finalized through a **transparent Lottery System**, if required which will be intimated later.
20. Authority reserves the right to reject any or all the tenders without assigning any reason thereof.
