Tenders in plain paper in sealed cover are invited for disposal of one outlived Diesel Ambassador Car bearing No.OR-02-K-8855 of the office of Director of Textiles & Handloom, Odisha, Satyanagar, Bhubaneswar- 751007 on as is where is basis.

- 1) The Tenders should reach in the O/o Director of Textiles & Handloom, Odisha, Satyanagar, Bhubaneswar-751007 duly superscribed as **“OFFER FOR PURCHASE OF VEHICLE NO.OR-02-K-8855 (AMB. CAR)”** addressed to the undersigned on or before 23.04.2021 by 5.30 P.M. at the latest and the tenders received shall be opened on dated 28.04.2021 at 3.30 P.M. in the presence of the bidders or their representatives.
- 2) The Tender Paper should accompany with E.M.D. of Rs.1,000/- (Rupees One Thousand) only in shape of Bank Draft drawn in favour of **Establishment Officer (DDO), Directorate of Textiles, Odisha, Bhubaneswar payable at State Bank of India, Bapuji Nagar Branch, Bhubaneswar** which will be refunded to the bidders, excepting the highest bidder whose tender will be accepted. The bid without Bank Draft will not be accepted.
- 3) The intending bidders are advised to inspect the vehicle in the office premises on any working day during the office hours.
- 4) The highest bidder whose tender will be accepted shall deposit 25% of the offered amount on the spot immediately after the confirmation of sale is made in his favour as the initial deposit and the rest amount (after adjusting the EMD) within 7 (seven) days from the date of acceptance of the Tender.
- 5) 18% GST is admissible shall be levied on the bidding cost by the successful bidder.
- 6) The successful bidder shall remove the vehicle from the office premises along with necessary documents of the said vehicle within 7 (seven) days from the date of deposit the full amount of tender. If the bidder failed to deposit the total amount as per the tender within the stipulated time, his deposits including EMD shall be forfeited. Failing which ground rent @ 1% of the bid amount per day shall be charged till removal of vehicle. If the ground rent so charged exceeds the sale price deposited, then the bidders shall cease to have any right to the vehicle & the amount deposited by him shall be adjusted towards ground rent.
- 7) The authority reserves the right to reject any or all the tenders received without assigning any reason thereof.
