 - b) As per Government of Odisha FDOM No.8943 dated 18.03.2021, the bidders are not required to submit 'Bid Security', but have to submit a 'Bid Security Declaration' in the Format appended herewith as **'Schedule-J'** which should be submitted in the letter head of the bidder signed by the bidder himself or by the Power of Attorney Holder.

- 9. The bid for the work shall remain valid for a period of **120 (One Hundred Twenty) days** from the date of opening of Price Bid. If any Bidder/ Tenderer withdraws his bid/ tender

before the said period or makes any modifications in the terms and conditions of the bid, the Bidder will be suspended/ prohibited/ debarred/ blacklisted from participating in bidding in any tender of the State including cancellation of empanelment for a minimum period of 180 days by the Authority/ Employer/ Tender Inviting Authority.
