General Information

For the sustainable development of the fisheries infrastructure like F.H. / F.L.C. along the coast of Odisha and to cater with the growing future demand of the coastal fisherman in their livelihood, the GoI as well as the GoO is very much keen in establishment of modern hygienic Fishing Harbour based on EU/HACCP norm. The said F.H. will facilitate safe landing and berthing of fish catch and craft in hygienic condition in eco-friendly environment. The hygienic handling of fish catch will provide value addition to their produce and generate good forex for the State.

The CICEF, Bangalore a Nodal Institution of Gol, Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying has prepared the TEFR/DPR on request of GoO, F&ARD Deptt. They have also carried out the Hydrographic/Topographic with soil exploration work at **Chudamani Fishing Harbour in Bhadrak District**, Odisha. Now, the TEFR/DPR for the aforesaid project has been completed at par with EU/HACCP norm to operate the proposed Fishing Harbours in hygienic condition. Since, the EC from MoEF & CC as well as CRZ clearance from OCZMA and NOC from different nodal agencies of Gol and GoO is mandatory and pre-requisite for implementation of the project, the Director of Fisheries, Odisha has called for Expression of Interest from NABET accredited organizations who has enrolled under 7 (e) for carried out the EIA/EMP study on Ports and Harbour projects.

Project Details

1. Fishing Harbour at Chudamani in Bhadrak District

The Fishing Harbour is located in Southern Bank of river Gomei. The site is very close to the confluence point of Bay of Bengal on lat. 21-08 N and Long. 86-47 East. The site is 42 km away from the district head quarter, Bhadrak and is about 175 km from away from State capital Bhubaneswar.

Chudamani is one of the most potential site in Northen Odisha. The proposed project proposal has been designed over an area of 63.13 Ac. and will accommodate 9m FRP – 85 nos., 12 m Trawler – 55 nos., 14 m long -70 nos. total of 210 Nos. with a harvesting capacity of 9650 Ton per annum (TPA). About 10000 people will be directly and indirectly benefitted out of which 2,000 fishermen/ stakeholders/ local vendors will be directly benefitted in their livelihood. The estimated cost of the project is **Rs. 3215.00 lakhs**.

The project components envisage the Reclamation, Quay-Diaphragm Wall, Beach-Landing Revetment, Sloping Hard, Internal Asphalt Road, Vehicle Parking Area, Concrete Surfacing For Fish Landing, WBM surfacing for boat Parking/Repair Yard, Fish Merchant Dormitory, Fish Handing Auction Hall (MFVs), Radio Communication Tower, Fishery Administrative Office, Fishermen Gear-Shed, Net-Mending Shed, Fishermen Rest Shed, Boat Repairing Shop,



Restaurant, Public Toilet, Main Gate and Guard House with provision for fresh water supply system, navigational aid, power and lightening, greeneries and landscaping, Post-Environment Impact Assessment & Monitoring, drainage and sewerage in all respect at par with the requirement of the stakeholders.

Invitation of Expression of Interest (EoI)

Expression of Interest (EoI) in sealed cover are invited from State PSUs / Central PSUs / Govt. Environment Consultants / Govt. Educational Institutions/ Research & Development Organization/ Private Farms having NABET accreditation or Joint Venture with NABET accredited Farm who are accredited with Quality Counsel of India (QCI), NABET Accreditation Board of Education & Training publish by MoEF vide OM F. No. J-11013/77/2004-IA-II (i) Dtd. 30.09.2011 and subsequent revision having experience carrying out EIA Study & obtaining E.C. from MoEF & CC, Gol and CRZ Clearance from OCZMA, the details of eligibility criteria and other specific and general conditions are given in the document.

Sealed offers (Cover-I & II) prepared in accordance with the procedure & conditions enumerated in Instruction to Bidders, General Condition, Special Condition, ToR etc. should be submitted to the Director of Fisheries, Odisha, Mangalabag, Cuttack on or before 04.05.21 by Speed Post/Courier/Registered Post.

Instruction to the Bidders:-

The sealed cover of EoI must be sent in one main cover containing 2 separate cover shall be super scribed as Cover-I & Cover-II respectively. Names and Address of the Bidders shall be written in all the covers. The sealed cover must be super scribed Consultancy services for conducting EIA/EMP study and obtaining E.C. and CRZ Clearances on turnkey basis as per MoEF guideline and amendments thereof for Construction of Fishing Harbour at Chudamani in Bhadrak District, Odisha. The Bidders before quoting shall visit different sites and see himself the existing Environment to get the first hand knowledge of the condition and the Environment, available facilities etc. in order to offer liable proven Consultancy Services. The Bidders shall not hold Director of Fisheries, Odisha, Cuttack (DOF) responsible for furnishing / missing any relevant information.

Sealed cover-I must be super scribed as "Technical Bid" & sealed Cover-II must be super scribed as "Price Bid" both the sealed covers must be super scribed as Consultancy services for conducting EIA/EMP study and obtaining E.C. and CRZ Clearances on turnkey basis as per MoEF guideline and amendments thereof for Construction of Fishing Harbour at Chudamani in Bhadrak District, Odisha and both Cover-I & Cover-II as mentioned above shall be sealed in a big cover. Any bid received after dead line for submission of bid will be rejected.

Cover-I shall consist of the followings:-

- d. Eligibility Criteria:-
 - I. The Consultancy firm should have valid accreditation in the Ports & Harbour sector categore-7(e) with Quality Council of India / NABET for carrying out EIA studies. Valid certificate shall be enclosed as proof without fail.
 - II. Documentary proof for which (i) Environmental Clearance from MoEF&CC and (ii) CRZ Clearance from State Coastal Zone Management Authority were obtained for at least 3 (three) projects in India in any Central / State / PSU / any reputed industry. Work order and copies of EC letters shall be submitted as documentary evidence without fail.

In case the bidder is a consortium of companies, the following requirement should be satisfied by the bidder.

- a. The member of the consortium should satisfy the minimum experience requirement as per d(i) above.

- c. The Cover-I, the Technical Bid of the EoI will be opened on 04.05.21 at 4 PM in the O/o. the DF(O) in presence of the bidder. Bidders should send letter of authorization on the firm's letter head with attested specimen signature or their representatives who wish to present / deputed to attend at the time of opening of EoI. Representatives without such authorisation letters may not be permitted to be present to witness the opening.
- d. The maximum number of persons representing the firm to witness the opening of the tender is limited to two.
- e. On the date of opening, only the Main Cover and Technical Bid (Cover-I) along will be opened. Cover-II will not be opened. All the sealed Cover-II of various bidders will be put inside one cover and sealed in the presence of the Bidders or their authorised representatives, who are present on the date of Technical bid opening.
- f. The date and time of opening of Price Bid (Cover-II) will be intimated to the Technically qualified Bidders based on the evaluation of their Technical Bid (Cover-I) and will be opened at the specified time and date in the presence of the representatives of the Bidders who choose to attend the price bid opening.
- g. All documentation required has to be in English language.
- h. DF(O) takes no responsibility for delay or non-receipt of EoI sent by Post and also reserves the right to accept or reject any or all the tenders in part or full, at any stage of the EoI process, without assigning any reason thereof.

- j. Validity of offer:- The validity of the EoI would be for a period of 120 days from the date of opening of Technical bids of the EoI and the validity can be extended on mutual consent.
- k. Earnest Money Deposit (EMD) / Performance Security:- The EMD shall be 10% of the offer price in shape of Bank Guarantee in any Nationalized Bank duly pledged in favour of the "Director of Fisheries, Odisha, Cuttack". Eol documents received without EMD amount will be rejected. The EMD shall be forfeited, if the Bidder withdraws his offer during its validity. The EMD of the unsuccessful bidders will be refunded once LOI is awarded to the successful bidder.
- 1. Conditional EoI will be rejected without assigning any reason.
- m. DF(O) at its discretion may extent the last date of submission of EoI and opening of EoI. GENERAL CONDITIONS

- 1. The Bidders shall specifically note that they should send their offer in time with all conditions indicated in the EoI document.
- 2. Bidders shall quote as a Lumpsum amount in Indian Rupees only and it shall be inclusive of all applicable charges including all taxes.
- 3. The rates in the tender bids shall be quoted both in words and figures. The price quoted in words would be final, in case is any variation between words and figures in the price bid. The rates should be firm without any escalation.
- 4. The EMD / Performance Security shall be 10% of the offer price in shape of Bank Guarantee in any Nationalized Bank duly pledged in favour of the "Director of Fisheries, Odisha, Cuttack".
- 5. The above deposit will be released to the Consultant on successful completion of the work within the period.
- Income Tax and other taxes shall be deducted at source as per the Rules
 of Government unless certificates, if any, for deduction at lesser rates or
 for nil deduction is submitted from appropriate authorities by the
 consultant.
- 7. The total Lumpsum amount quoted as per the Price Bid will be considered for finalizing the Lowest (L1) bidder on the offer being found techno commercially acceptable.
- 8. Award of Contract:- After evaluation and finalisation of price bids received, DF(O) will intimate the award of contract to the successful bidder by issuing Letter of Intent (LOI)
- 9. The successful Bidder have to bear the cost of stamp duty and charges for the purpose of executing the MoA.
- 10. The work is required to be carried out at Chudamani Fishing Harbour in Bhadrak District, Odisha.
- 11. No correspondence will be entertained by the DF(O) from any of the unsuccessful bidders.
- 12. The bidder is expected to examine the bidding documents carefully and are deemed to have received and read all documents. It shall be the responsibility of the bidder to request the copies of any missing documents. Failure to d so will be at bidders risk.

STANDARD TOR FOR FISHING HARBOUR PROJECT (ANNEXURE-A)

- 1. Reasons for selecting the site with details of alternate sites examined / rejected / selected on merit with comparative statement and reason/basis for selection. The examination should justify site suitability in terms of Environmental angle, resources sustainability associated with selected site as compared to rejected sites. The analysis should include parameters considered along with weightage criteria for short listing selected site.
- 2. Details of the land use break-up for the proposed project. Details of land use around 10 km radius of the project site. Examine and submit detail of land use around 10 km radius of the project site and map of the project area and 10 km area from boundary of the proposed/existing project area, delineating project areas notified under the wild



life (Protection) Act, 1972/critically polluted areas as identified by the CPCB from time and international to time/notified eco-sensitive areas/interstate boundaries boundaries. Analysis should be made based on latest satellite imagery for land use with raw images.

3. Submit the present land use and permission required for any conversion such as forest, agriculture etc. land acquisition status, rehabilitation of communities / villages

and present status of such activities.

4. Examine and submit the water bodies including the seasonal ones within the corridor of impacts along with their status, volumetric capacity, quality likely impacts on them due to the project.

5. Submit a copy of the Contour Plan with slopes, drainage pattern of the site and

surrounding area.

6. Submit the details of terrain, level with respect to MSL, filling required, source of filing materials and transportation details etc.

- 7. Examine road / rail connectivity to the project site and impact on the existing traffic network due to the proposed project / activities. A detailed traffic and transportation study should be made for existing and projected passenger and cargo traffic.
- 8. Submit details regarding R&R involved in the project.
- 9. Submit a copy of Layout superimposed on the HTL / LTL map demarcated by an authorized agency on 1:4000 scale along with the recommendation of the SCZMA.
- 10. Submit the status of shore line change at the project site.
- 11. Details of the layout plan including details of channel, breakwaters, dredging, disposal and reclamation.
- 12. Details of handling of each cargo, storage, transport along with spillage control, dust preventive measures. In case of coal, mineral cargo, details of storage and closed conveyance, dust suppression and prevention filters.
- 13. Submit the details of Fishing activity and likely impacts on the Fishing activity due to the project. Specific study on effects of construction activity and pile driving on Marine life.
- 14. Details of oil spill contingency plan.
- 15. Details of Bathymetry Study.
- 16. Details of Ship Tranquility Study.
- 17. Examine the details of water requirement, impact on competitive user, treatment details, use of treated waste water. Prepare a water balance chart.

- 25. Submit details of the trees to be cut including their species and whether it also involves any protected or endangered species. Measures taken to reduce the number of the trees to be removed should be explained in detail. Submit the details of compensatory plantation. Explore the possibilities of reloading the existing trees.
- 26. Examine the details of afforestation measures indicating land and financial outlay. Landscape plan, green belts and open spaces may be described. A thick green belt should be planned all around the nearest settlement to mitigate noise and vibrations. The identification of species/ plants should be made based on the botanical studies.
- 27. The Public Hearing should be conducted for the project in accordance with provisions of Environmental Impact Assessment Notification, 2006 and the issues raised by the public should be addressed in the Environmental Management Plan. ENVIRONMENTAL MANAGEMENT PLAN (EMP)

Environmental Management Plan will be developed to selectively mitigate the adverse impacts due to the construction and operation of various activities planned for the proposed project. Any modification needed to make the project environmentally compatible will also be suggested. Based on the identified potential impacts associated with the project, an EMP shall be framed for the construction and operations phases of the project, which shall include the following minimum:

- Analysis of the various mitigation measures and recommendation of feasible and cost effective measures
- Environmental monitoring programme for the construction and the operation phases
- Budgetary estimates for implementation of the EMP will be based on the following considerations;
- Management of effluent construction phase
- Solid waste management and disposal during construction phase
- Control of air pollution during construction phase
- Control of noise during construction phase



- Green belt development and area greenery planning
- Mitigation of impacts on marine ecology
- Noise control measures during operation phase
- Treatment and disposal of effluents from port, back up area & other related areas
- Management of impacts due to reclamation works
- Recommendation SEIAA in their supplied ToR specified for the project.

RISK ANALYSIS AND DISASTER MANAGEMENT PLAN

Risk Analyses

The proposed project does not envisage the handling and storage of hazardous material. However, Risk Analysis and DMP shall be prepared as part of the Environmental management Plan. The terms, 'hazard' refers to sources of potential harms, and denotes a property or a situation which in particular circumstances could lead to harm. Risk on other hand, is a function of the probability of a hazard occurring, and the magnitude of the consequences. Risk therefore, represents the likelihood of a potential hazard being realized. Risk Estimation involves identifying the probability of harm occurring from an intended action or accidental event. Risk Analysis broadly comprises of the following steps:

- Risk Assessment for accidents at site and its impact on adjoining area,

Disaster Management Plan

Disaster Management Plan including emergency evacuation during natural and manmade disaster like floods, cyclone, tsunami and earth quakes etc. Required infrastructure shall be suggested as a part of DMP.

HTL/LTL DEMARCATION

The Ministry of Environment and Forest has also provided guidelines for demarcation of High Tide Line in the CRZ Notification, 2018. As per the guidelines, Project specific HTL/LTL demarcation needs to be done for the projects seeking CRZ clearance. HTL/LTL demarcation can be done through one of the 8 agencies approved by MoEF for HTL/LTL demarcation. Therefore project specific HTL/LTL demarcation shall be carried out through one of the authorized agency approved by MoEF & CC.
