NOTICE INVITING TENDER (NIT)

NATIONAL COMPETITIVE BIDDING THROUGH e-Procurement

The **Executive Engineer, P.H. Division, Keonjhar**, Tender Inviting Authority (TIA) on behalf of Governor of Odisha invites sealed tenders in two bid systems(Part-I Technical bid and Part-II Financial bid) in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) from eligible bidders meeting the minimum Eligible Criteria for supply of materials as detailed herein, which is to be delivered at P.H. stores at **Keonjhar**. The bid should be submitted on-line in the website **www.tendersorissa.gov.in** by eligible manufacturer. The bidders should have the necessary Portal Enrolment with his own Digital Signature Certificate.

- Mode of Submission of tender: Tender should be submitted online in **www.tendersorissa.gov.in**
- The bidders desirous to participate in bidding must possess compatible Digital Signature Certificate of Class-II or Class-III and should follow the changes/ modifications/ addendum to DTCN if any.
- The original documents i.e. Affidavits, Undertakings certificates as per the schedules and Annexure of DTCN that have been uploaded by the bidder in the e-tender website should be submitted for verification during evaluation.
- The bidder should make payment through online receipt towards Tender Paper Cost and EMD. No off line receipt of Tender Paper Cost and EMD will be allowed in e-Procurement portal of Government of Odisha.
- The scanned copy of Registration Certificate, GST, PAN, Affidavits including required papers up loaded through website should be produced in original to the **Executive Engineer,**

P.H. Division, Keonjhar for verification by **17:00Hrs of dt. 22.04.2021** so as to enable opening of Technical Bid i.e., at **17Hour of dt.23.04.2021**.

8. **Minimum Eligibility Criteria :-**

Bidder shall fulfill following eligibility (Qualification) Criteria.

9. The Bidder should have not been black listed by any Govt./ Govt. Undertaking on the bid opening date. Self-declaration certificate by Bidder in the form of Affidavit is to be submitted.
10. The manufacturers should not be black listed/debarred/disqualified with respect to the quality issues by any Govt./Govt. undertaking as a procuring entity, for supply of DI pipes in India, in the last three years from the date of submission of the tender (Self-declaration certificate shall be submitted by the manufacturers in the form of affidavit).
11. The bidders who have in last 3 financial years applied for/ are undergoing corporate debt. Restructuring (CDR) / Strategic Debt Restructuring (SDR) or facing recovery proceedings from Financial Institutions or those are facing Sickness and under consideration of Board for Industrial and Financial Reconstruction (BIFR) are not eligible for qualification. Self-declaration certificate by the bidder in the form of affidavit is to be submitted.
12. The manufacturers should have valid BIS license for making ISI mark on their product for at least 5(five) years by last date of bidding.
13. The manufacturers DI pipes and fittings are in satisfactory performance in Indian project for at least three years.
14. The bid for the work shall remain valid for a period of **120 (One Hundred Twenty) days** from the date of opening of Price Bid. If any Bidder/ Tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
15. Bids from Consortium/ Unincorporated Joint Venture is not acceptable.

16. Other details can be seen in the bidding documents, which is available in website **www.tendersorissa.gov.in**.
17. All amendments, time extension, clarifications etc. will be uploaded in the website only. Bidders should regularly visit the above website to keep themselves updated.
18. Authority reserves the right to reject any or all the tenders without assigning any reasons thereof.
