NATIONAL COMPETITIVE BIDDING THROUGH e-Procurement

The **Executive Engineer, P.H. Division, Balasore** on behalf of Governor of Odisha invites **Percentage Rate Bids** through **e-Procurement** in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) in Single Bid system (Price Bid) from Appropriate **Class of Contractors** registered with the Odisha State Government and Contractors of equivalent grade/class registered with Central Government/ any other State Government/ MES/ Railways fulfilling minimum eligibility criteria as stated hereunder and other detailed qualifying requirements given in the DTCN to be eventually drawn up in the **Standard P-1 Contract Form of Odisha PWD**. The bid should be submitted on-line in the website www.tendersodisha.gov.in by eligible class of contractors. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). Contractors registered elsewhere but not registered with Government of Odisha can also participate in the e-procurement after necessary enrolment in the portal but have to subsequently register themselves with the appropriate registering authority and CDMS of the State Government before award of work / signing of the Agreement as per prevalent registration norms of the State.

- Mode of Submission of tender: Tender should be submitted online in www.tendersodisha.gov.in.
- The bidders desirous to participate in bidding must possess compatible Digital Signature Certificate of Class-II or Class-III and should follow the changes/ modifications/ addendum to DTCN if any.

4. a) The bidder should make payment online towards Tender Paper Cost. No off line receipt of Tender Paper Cost will be allowed in e-procurement portal of Government of Odisha.
- b) As per Government of Odisha FDOM No.8943 dated 18.03.2021, the bidders are not required to submit 'Bid Security', but have to submit a 'Bid Security Declaration' in the form of a Notarised Self Affidavit that "if they withdraw or modify their bids during period of validity etc., they will be suspended for a period of 3 (three) years from the Bid Due Date from participating in any tender floated by the division"

7. The Bidder should not have been black listed by any Govt./ Govt. Undertaking on the bid opening date. **Self-declaration certificate** by Bidder in the form of Affidavit is to be submitted.
8. **Registration in the contractors Data Base Management System (CDMS) available at www.cdmsodisha.gov.in by all contractors is mandatory. (as per Para 12.4, Appendix-IX(A), OPWD Code-Vol-II). Tenders of contractors who have not registered under CDMS portal will not be accepted.**
9. The bid for the work shall remain valid for a period of **120 (One Hundred Twenty) days from the date of opening of Price Bid**. If any Bidder/ Tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the bidder shall be suspended for a period of 3 years from bid due date.
10. Bids from Consortium/ Unincorporated Joint Venture is not acceptable.
11. Other details can be seen in the bidding documents, which is available in website www.tendersorissa.gov.in.
12. All amendments, time extension, clarifications etc. will be uploaded in the website only. Bidders should regularly visit the above website to keep themselves updated.
