#### 6. <u>Minimum Eligibility Criteria :-</u>

- i) Registered Contractors should have successfully Completed & Commissioned Works of similar type valuing not less than <u>Rs.83.49 Lakhs</u> (30% of the estimated cost) in any one financial year during the last 5 (five) years. The firm shall have to submit the performance certificate of completed & commissioned works constructed by them for satisfactory performance from appropriate authority i.e. not below the rank of Executive Engineer / equivalent. Weightage @ 10% per year shall be given on the value of the completed work in the preceding years.
