On the recommendation of the Odisha Public Service Commission pursuant to the advertisement No. 11 of 2018-19, the following candidates are hereby appointed temporarily as Assistant Professors in the respective disciplines as mentioned below under OMES Cadre of Health and Family Welfare Department in the pay band of Rs.15,600/- to 39,100/- with AGP of Rs.8,000/- (pre-revised) per month and in the Academic Level 12 of First Schedule of this Department Notification No.33012 dated.16.12.2019 with other allowances as admissible from time to time from the date of their actual joining in the post or until further orders.
