- 26. - 29. Bid for the work shall remain opened for acceptance for a period of 90 days from the last date receipt of Bid. If any Bidder/tenderer withdraw his or her bill /tenderer before the said period or makes any modification in terms and conditions of the bid ,action shall be taken as per codal rules,
- *30.* Submission of fake TDRs shall be liable for rejection of Bids and criminal action shall be initiated against the concerned bidders. The agreement of the 1st lowest bidder after transparent lottery shall be executed after necessary verification of TDRs from the concerned Bank/ Post Office.

- **31**. The bidder shall have to furnish the No relation certificate along with the bid documents to the effect that no officer of the Department to the rank of Junior Engineer or above is related to him.
- 32. The intending bidders should offer their rates excluding GST. The GST as applicable for the work contract shall be paid over bill amount of the work at the time of payment of each bill. The amount put to tender is exclusive of GST.
- **33**. OGST @ 1% & CGST @ 1% on the Gross amount of the bill shall be deducted from the contractor's bill as tax deduction at source (TDS). In case of interstate supply IGST @ 2% shall be deducted.
- 34. Quality control tests as per specification for all items of the work executed will be taken in nearby Government Quality Control Laboratories of Minor/Medium/Major Irrigation Organisation. It is binding on successful bidder to extend all necessary support in getting the tests done till completion of the work in all respect at his own cost.
